With due respect I, Smt. Sabitri Roy, W/o Sri Anil Chandra Roy, of Majhabari, Fakdai bari, Ashighor, Dist. Jalpaiguri would like to inform you that I am the Secretary of the Mahila Samiti/Bazar Committee of Majhabari & Fakdai bari. I, along with other members, we are organizing Durga Puja at the Majhabari Fakdai Bari Bazar, after getting due permission from the concerned Police Department. We have even received a sum of Rs. 60,000/- from the State Government as Puja Donation.

While doing our Puja work today at about 3.00 PM some anti-social elements namely.  
1. **Abhi Sutradhar**, S/o Sri Ananda Sutradhar, of Naresh More, P.O. Ghughumali. P.S. Ashighar, Dist. Jalpaiguri, 2. **Dipankar Das**, and 3. **Pijush Das**, both Sons of Sri Kalipada Das, of Majhabari, Fakdai bari, Ashighar, Dist. Jalpaiguri, rushed to our Pandal which is constructing in front of the Mandir, and threatened us with dire consequences and badly abused us using filthy languages in presence of our other members namely. Anil Chandra Roy, Subal Chandra Roy, Sushil Roy and others, lastly by saying, "You people immediately stop doing this work and dismantle the pandal otherwise we will burn your pandal tonight." Further they were showing iron rods, sabals, lathi, talwars, vala, bhujali and threatened to kill of us.


As per information gathered we came to know that these anti-social elements are habitual offenders and gone to jail several times.
