I, **SMT. MONIKA SINGH**, wife of Sri Biswajit Singh, resident at Champasari Main Road, Ward No.46 of Siliguri Municipal Corporation, Post Office & Police Station: Pradhan Nagar, Siliguri, District: Darjeeling, in the State of West Bengal would like to request you for your kind information and necessary action as follows:-

1. That I am the register and recorded owner of land area measuring 11(Eleven) Katha recorded in R.S. Khatian No.20/2 comprising to L.R. Khatian No.3428, Plot No. R.S. 187 corresponding to L.R. Plot No.307, under Mouza: Kalkut, J.L. No.044, Touzi No.91, Pargana: Patharghata, within Police Station: Pradhan Nagar, Siliguri, District -Darjeeling, in the State of West Bengal purchased in two different dated deeds bearing No.1-5618 for the year 2011 and I-5239 for the year 2013 from one Sri Raj Kumar Gupta, Son of Sri Jagdish Prasad of S.F. Road, Siliguri and the deed was recorded in the office of A.D.S.R. Siliguri-II at Bagdogra and from the date of such purchase I became absolute owner of the said land is in actual, khas and physical possession on and over the said land having permanent heritable, transferable, right, title, interest therein and have been possessing and enjoying the same free from all encumbrances whatsoever.

2. That thereafter I have applied for mutation of my aforesaid landed property to concerning office i.e., B.L.&L.R.O. Matigara and one separate Khatian was issued from the concerning office vide L.R. Khatian No.3428 and then and there I was bounded my aforesaid landed property from brick wall and in front I was made tin shed iron shatter shop and was peaceful possession of my aforesaid property.

3. That in the adjacent of my aforesaid property my Father-In-Law Sri Ram Sakha Singh S/o Lt. Bhogi Singh has an area of land measuring 5(Five) Katha 4(Four) Chhatak and my Mother-In-Law Smt. Parbati Devi, W/o Sri Ram Sakha Singh has area of land measuring 5(Five) Katha 4(Four) Chhatak in the same Plot No. 187 and Khatian No.20/2 & 22/2 within same Mouza: Kalkut.

4. That today dated: 30-09-2022 in the evening at about 05:30 p.m. one Vinod Kumar Jaiswal, Son of Rajendra Prasad Jaiswal resident of Champasari, Pradhan Nagar, Siliguri and also reside at J4, 12 Civil Township, Sundargarh, Rourkela, P.O. & P.S. Raghunath Pali, District: Sundargarh, along with his 10 to 14 anti social land mafia came at my aforesaid landed property and they are destroy boundary wall and tin shed shop's shatter and try to grab my aforesaid property and when I have come to know aforesaid incident and when I reached at my aforesaid property with my wishers namely Subal Paul son of Lt. Bhola Nath Paul, Mohan Singh son of Sri Nageshwar Singh along with my husband then they using filthy languages against us and tear my saari and pushed me and they suddenly attacked with Iron rod on the body of Subal Paul and Mohan Singh they are brutally injured and they forcibly try to capture my aforesaid landed property. I cried for help-help then they fled away from my aforesaid landed property and said they any how grab my aforesaid landed property if we obstruct their illegal motive then they are not hesitate to kill us. Sir I and my family members are feared their ill motive.

So under the above circumstances I therefore request you kindly enquire the matter and immediate arrest the accused Vinod Kumar Jaiswal and their 10 to 14 antisocial land mafia as per provision of law and also save my aforesaid landed property from the aforesaid land mafia. For this I shall always oblige to you
