Respected Sir,

I, Vinod Kuamr Jaiswal, son of Rajendra Prasad Jaiswal, r/o J4, 12 Civil Township, Sundargarh, Rourkela, P.O & PS – Raghunath Pali, Dist – Sundargarh, Orisha, Pin – 769004, begs to inform you that I have purchaser a plot of land as fully described in the schedule below by virtue of a registered deed duly executed by one Anupam Kumar Kundu and Nabendu Kumar Kundu both sons of late Shymal Kumar Kundu, resident of Siliguri, which was duly executed in the office of the ADSR Bagdogra, being document no. I – 4079/2021 and I – 4080/2021 and thereafter the said land was duly mutated in my name being khatian no. 5655 and I am still holding, occupying, possessing and enjoying the said land.

That it is very much unfortunate that as there are so many land mafia people are loitering in and around the locality and taking the opportunity of the fact that I am a outsider the said land mafia and land grabbers namely 1) Ram Sakha Singh Sardar, son of Late Bhogi @ Bhugani Singh, 2) Ajit Kumar Singh @ Rangila, son of Ram Sakha Singh Sardar 3) Biswajit Singh @ Azad Ram Sakha Singh Sardar and 4) Monika Singh, daughter in law of Ram Sakha Singh Sardar who without having any right and title are constantly trying to illegally encroach my land but due to my strong objection and resistance they are unsuccessful.

But lastly on 12/09/2021 this people namely 1) Ram Sakha Singh Sardar, son of Late Bhogi @ Bhugani Singh, 2) Ajit Kumar Singh @ Rangila, son of Ram Sakha Singh Sardar 3) Biswajit Singh @ Azad Ram Sakha Singh Sardar came to my land with 10 to 15 goons and tried to encroach my land for their illegal means and when I raised my objection resistance they all left but threatened me to the fact that I need to pay a gunda tax of Rs. 10,00,000/- (Rupees Ten Lakh) only to them as because I have purchased land in their locality and if I don't comply there illegal demand they are going to oust me of my land and further more they will not hesitate to kill me.

That again on 14/09/2021 1) Ram Sakha Singh Sardar, son of Late Bhogi @ Bhugani Singh, 2) Ajit Kumar Singh @ Rangila, son of Ram Sakha Singh Sardar 3) Biswajit Singh @ Azad Ram Sakha Singh Sardar along with other men again came to my land demanded that I shall pay them Rs. 10,00,000/- (Rupees Ten Lakh) if I want my land free from all encumbrances and as I refused and resisted to their illegal act and demand they all abused me with filthy language and manhandled me and my company who accompanied me to my property.

That thereafter I being a law abiding citizen of the country made a official complain to the Pradhan Nagar police station and as such the police station registered my complain being Pradhan Nagar PS case no. 743/2021 under various sections of IPC.

That on 20/09/2022 at about 4.00 pm when I went to my land again for proper care and maintenance at that time 1) Ram Sakha Singh Sardar, son of Late Bhogi @ Bhugani Singh, 2) Ajit Kumar Singh @ Rangila, son of Ram Sakha Singh Sardar 3) Biswajit Singh @ Azad Ram Sakha Singh Sardar and 4) Monika Singh they all came along with 10 to 15 local goons with deadly weapons and started to threatened me that if I don't with drew the criminal case then they will not hesitated to kill me and take forcible possession of my land and when I and my accompany raised objection they all manhandled me and assaulted me and said that they have prepared false deeds and documents in their name so that they can sale the land to third party representing themselves as the actual owners of the land.

Thereafter I have lodged a criminal complaint against the above named persons at Pradhan Nagar PS case no. 744/2022. But it is very unfortunate that even after registering this case also again on 30/09/2022 again at 5.00 p.m. all this persons along with 20 unknown men came to my land again with deadly weapons such as sword, khukri, road, bhala, etc and tried to encroach my land again but again I raised strong objection with the help of my well wishers and then at that time Biswajit Singh @ Azad Ram Sakha Singh Sardar attacked me with a khukri and threatened me to withdraw all the criminal cases I have filed against them and also to vacate the land or he will kill me today and he will dump my body in such a place so that my family or even the police will not be able to find my body.

That when I again resisted them and restrain them from encroaching my land illegally Biswajit Singh @ Azad Ram Sakha Singh Sardar he intentionally to kill me swing the khukri to wards by neck but somehow I escape and the due to the large hue and cry the other local neighbors came out to help me and then they all left the place but they all threatened me that they will come again and kill me and will take the land in their possession.

That I am a law abiding citizen of this country and being a law abiding citizen I am constantly trying my label best to maintain the peace and order but this people are all involved in land mafia activities and they can go at any extent to fully fill their illegal activities and they will not hesitated to even kidnap me and kill me.

Sir, I am under constant fear for my life and property and this is my humble request to you that to take proper and strict legal action against this people.
