I, Sahira Banu W/o. Sabarath R/O. Madgora  
Bazar, PS. Matigara Dist. Dargeeling. beg  
report you the following facts: -

1. That I have been residing along with my old aged widow mother namely Salma Begum at above noted address since long. My mother is suffering from Vauicai ment due to her old ages related di sence. She is completely bedridsens.
2. That adjacent to my house and land one namely pappu s/o. Suresh, residing at Matigara old fish market, PS. Matigara Dist. Dargeeling with some unknown miseris-ent's namely Dildor s/o. Bismath Sahami Saleman s/o. Bismath Sahami MD. Muslim s/o. MD. Vhusalu, MD. Vhusalu s/o. MD. Chitalu have/had consume alcohol at Puerious night Dt. 11.09. 2022 at about 10.30. P.M. night.

Therefore while I raises objection as stopped this illegal acts and at activities of abovenamed alleged person then said pappu and all four alleges person started quarrel with me and abuses me in obseobcenc langange. I protested the matter then said pappu dragges me on the ground by Catcheing hairloc and assulles me by fists and blows.

There after said Pappu immense physical assaulted me by blows and by kicks on my breast and my abdomen and said Pappu along with all four alleged person started to drag me by catching my both hand and they took my wearing apparels completely. At this time I was screaming and hearing that my old aged widow mother rushed at the spot to save me then said Pappu abuses her on the ground by dashing they also threatened us to "RAPE and MURDER US".

3. That therefore, I was extremely shocked and incurred lots of fear in my mind at the present moment.

That the xerox copy of Medical Prescription issued by ~~the~~ Matigorra Hospital Dated - on - 11.09.2022, is annexes herewith with this application for kind perusal of your concern authority.

4. That it is pertinent to mention here that said Pappu (details as states above) is continue threatening to as that "if I will go to police station to lodge complain against them then Sahira Banu will Rape and murder by them" Due to my personal problem and work Lodging my F.I.R. too late.

therefore I requested to take necessary action against above namely (Pappu, Dildar, Saleman, MD. Muslim and MD. Vhusalvi) alleged person as early as possible for administration of justice.
