Respected Sir,

I, **JAI PRAKASH GUPTA**, SON LATE RAMESHWAR PRASAD GUPTA, am permanent resident of "Targer Cottage", J. N. Mitra Road, Chandmari, Post Office Chandmari, Police Station and District Darjeeling. I own and possess a plot of land measuring 4 (four) Katha, situated at close proximity of Gitanjali Hotel, Mandlaguri, appertaining to R. S. Khatian No.61/5, R. S. Plot No.472, within Mouza Mandlaguri, J. L. No.107 (85), Ward No.46 of S. M. C. Post Office and Police Station Pradhan Nagar, District Darjeeling, photocopy of said Sale-Deed attached herewith for your kind perusal. Aforesaid land is under my peaceful possession and occupation since 2008 and having approx. 5" feet height boundary wall from all the sides.

I came to know from one Mr. Jai Prakash Yadav, Son of Late Satya Narayan Yadav, resident of "Sarda Green Apartment", Bandrijote, Dagapur, about 4 days ago that one Mr. Rajesh Oraon, Son of Late Sonichar Oraon, resident of Liehubagan, under Police Station Matigara, District Darjeeling alongwith his associates broke one side of my boundary wall and trying to capture my land. Aforesaid Rajesh Oraon is known notorious person and land mafia. He has been several times apprehended by the police and number of cases of land grabbing is pending against him. He was recently arrested by the Siliguri Police Commissionerate in its crackdown against land mafias and currently is under bail. He has threatened me that he will definitely capture my land, if I did not concede to his demand to sell my land to him on meagre amount, otherwise I fail to give him Rs.10,00,000/- (Rupees Ten Lac) Only to him and his associates.

Sir, I am a peace loving and law abiding citizen, and moreover I resides in Darjeeling and a serviceman of I.L.C.I. and not in a position to always present here and look after my land. Aforesaid land mafias are taking advantage of present situation of closure of local Courts and engagement of Police Administration in Durga Puja has chosen the occasion to capture my land.

I, therefore, request you to take immediate steps against land mafia Rajesh Oraon and his associates and restrained them from illegally capturing my land.

I shall be grateful to you for this kind act.
