Respected sir,

I Alivia Sarkar, D/o Sri Abhijit Sarkar, residing at Aban Thakur Sarani, Prova Apartment, Deshbandhupara, Near Deshbandhu Sporting Club beg to lodge this information/ FIR to your goodself to the effect that during the period 2020 I was studying in SIT, Siliguri while Sri Swarna Kamal Basu, S/o Sagar Kanti Basu resident of Ashiyana Complex, P9JM +65W, opposite of Royel Academy School, Matigara, P.S. Matigara, District Darjeeling, was a student of senior class at the SIT, Siliguri and as such he knew me from the said S.I.T., college Siliguri.

While I am doing my internship of Hotel Management in ITC Hotel, Kolkata during the period of October, 2019 to January, 2020 staying myself alone at my parent's flat at Baguihati, Kolkata when the said Swarna Kamal Basu came to said ITC Hotel, West Bengal at Kolkata and seeing me there he called me and stated me that he is working as chef in Oberoi Hotel at Chennai and has come to I.T.C Hotel West Bengal at Kolkata for some work and at that time he took my flat address of Baguihati where I was residing at the relevant time.

After few days thereafter said Swarna Kamal Basu came to my flat at night at Siliguri due to my medical purpose when I was unconscious and stayed at my flat.

During night I became unconscious for what I don't know (may have feed me some drug or so by said Swarna Kamal Basu and in the morning I became conscious and some time thereafter he left my flat.

Since June, 2022 said Swarna Kamal Basu started threatening me saying that unless I give him Rs. 1.00 lacs to him immediately he will sell my naked photographs to some portal and shall send to Facebook too and used to call me frequently demanding money and also threatened me saying that he will rape me and then kill me with acid attack and also will kill my parents too.

Due to such threat and fair of rape and my life and my parents to I compelled to pay Swarna Kamal Basu on jail.

Such messages also sent me through message in my cell phone too today at about 12:48p.m. He sent a message stating "aj Khali office theke bero trpr rape kore mere fele rakhbo".

Yesterday i.e. 30.09.2022 at about 7.30 pm I received a call from phone number 3344099090 from Smt. Banani Basu who told that she is mother of Swarna Kamal Basu and told that I will kill your family, will rape you and nobody will understand. Give me Rs.

3.00 lacs I will delete your videos. My son will go to your home and give him that money.

From the Modus operandi of the above accused persons viz. Swarna Kamal Basu, his mother Banani Basu and their associates it is apparent that they are very much notorious person and habitual criminals and may rape me and kill us at any time.

My and parents' lives are very much unsafe/ unsecured.

I therefore, lodge this complaint to you against said accused persons viz. Swarna Kamal Basu, his mother Banani Basu and their associates to arrest them immediately and to prosecute them accordingly to law keeping them in iron bar otherwise they will rape me and kill me and my parents too at any time and they may abscond at any time if they are not immediately arrested and kept in iron bar.
