Malati Roy, Wife of Saden Roy, sister-in-law, Tumpa Roy, my Jaa, Namita Roy, and husband of my sister-in-law, Anup, all are resident of Bidyachakra Colony, Ward No.44 of SMC, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri.

Respected Sir,

I, **SMT. NILIMA ROY**, Wife of Sanjib Roy and Daughter of Gajendranath Roy, presently residing at Vivekananda Nagar, Ward No.42 of SMC, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my husband, Sanjib Roy, Son of Shri Saden Roy, my father in-law, Sri Saden Roy, Son of not known, mother-in-law, Smt. Malati Roy, Wife of Saden Roy, Tumpa Roy, my Jaa, Namita Roy, and husband of my sister-in-law, Anup, all are resident of Bidyachakra Colony, Ward No.44 of SMC, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri. to the effects as follows:-

- (1) That my marriage was solemnized in the year 2009 with said Sanjib Roy as per Hindu rites, rituals and customs.
- (2) That out of the aforesaid wedlock, I gave birth to one female and one male babies who are presently aged about 12 years and 10 years respectively and their birth certificates are in the custody and possession of my husband and in-laws.
- (3) That after the birth of my female child, my husband and in-laws used to commit mental and physical torture upon me at regular interval without rhymes and reasons and for some minor discrepancies of household works.

- (4) That my husband is an alcoholic and consumes alcohol regularly and used to commit cruelty both mentally and physically upon me and my in-laws used to aid and abate my husband in committing the same but I did not lodge any complaint regarding the mental and physical torture upon me by my husband and in-laws to any police station or to any authority in the hope and expectation that after the elapse of time, their attitude and behavior towards me would be conducive and proper but in vain.

(5) That on 01-10-2022 at about 11:00 p.m., my husband in an intoxicated state abused me in filthy languages and thereafter my husband along with my in-laws above-named mercilessly assaulted me physically. My husband hit on my head with cooking pot and they threatened me to leave my matrimonial home or to face dire consequences. Due to the assault, I sustained multiple abrasion and scratches upon my person and on my head. I went to Siliguri district hospital on 02-10-2022 for my treatment and thereafter out of their fear, I was compelled to leave my matrimonial home and presently took shelter in my parental home.

So, therefore, I humbly request you to take necessary legal action against my husband and said in-laws at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
