consequences against me and my family.

House my Husband doing Job as Industry,  
Department (IDO) officer who is presently  
posted at Jalpaiguri so Sir I am passing  
my days very fearfully along with my two  
little children

So there for I request you to table all  
necessary legal steps against ~~an~~  
Amirul Islam and Burry and protect me  
and my family members life
