In producing herewith the 07 (Seven) accused persons namely (1) Ranjan Mandal@ Ranjay (34) S/O Sri Ratan Mandal of Panchanan Road, Netajipara, Uttar Shantinagar, PO- Goghomali, PS Bhaktinagar Jalpaiguri (2) Samir Das (26) S/O Lt Shyamal Das of do (3) Bhabaranjan Mandal (35) S/O Lt Souvagya Mandal of do (4) Sumit Das (27) S/O Sri Sambhu Das of Netaji Colony (Near Ambedkar Club), Ward No- 37, PO- Goghomali, PS Bhaktinagar Jalpaiguri (5) Biswajit Saha (28) S/O Sri Bablu Saha of Niranjannagar, Ward No- 36, PO- Goghomali, PS Bhaktinagar Jalpaiguri (6) Babai Karmakar @ Potla (33) S/O Sri Nanda Gopal Karmakar of Arabindapally (Near Italian Math), Ward No-37, PO- Goghomali, PS Bhaktinagar Jalpaiguri and (7) Gourav Rana (26) S/O Lt Prem Rana of Paulpara, PO- Shibmandir, PS Matigara, Darjeeling along with the following seized articles with seizure list;

I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar PS lodged a written complaint against the above noted accused persons to the effect that on 04.10.2022 at 00.35 hrs received information that a gambling was going on inside of under construction building with Pakka shed of Bhabaranjan Mandal of Uttar Shantinagar, PO-Ghogomali PS - Bhaktinagar Dist- Jalpaiguri. Accordingly I diarized the matter vide ASG OP G.D.E. No. 74 dtd. 04.10.22 & informed the matter to O.C Ashighar OP and as per his kind direction, myself along with SI Swapan Kr Ghosh, ASI Inzamamul Hoque, ASI Amit Mallick, Const 1181 Bhobesh Ch Roy, Const- 376 Shymal Choudhury CV- 307 Ful Kumar Roy all are of Ashighar OP left for the spot to verify the veracity of information vide ASG OP G.D.E.No. 75 dt- 04.10.2022 On arrived at 00.55 hrs at the spot found that the above noted accused persons and others are playing gambling with the help of playing card to each other by cash to wrongful gain and wrongful loss and on seeing the police party they try to flee away from the spot but on hot chased police party apprehended the above noted accused persons namely (1) Ranjan Mandal@ Ranjay (34) S/O Sri Ratan Mandal of Panchanan Road, Netajipara, Uttar Shantinagar, PO- Goghomali, PS Bhaktinagar Jalpaiguri (2) Samir Das (26) S/O Lt Shyamal Das of do (3) Bhabaranjan Mandal (35) S/O Lt Souvagya Mandal of do (4) Sumit Das (27) S/O Sri Sambhu Das of Netaji Colony (Near Ambedkar Club), Ward No- 37, PO- Goghomali, PS Bhaktinagar Jalpaiguri (5) Biswajit Saha (28) S/O Sri Bablu Saha of Niranjannagar, Ward No-36, PO- Goghomali, PS Bhaktinagar Jalpaiguri (6) Babai Karmakar @ Potla (33) S/O Sri Nanda Gopal Karmakar of Arabindapally (Near Italian Math), Ward No-37, PO- Goghomali, PS Bhaktinagar Jalpaiguri and (7) Gourav Rana (26) S/O Lt Prem Rana of Paulpara, PO- Shibmandir, PS Matigara, Darjeeling. On being searched at the spot (i) Cash Rs. 49130 /- as Board money (ii) 05 packets of playing cards (iii) 10 pices of used candels (iv) 10 numbers of empty bottles of Beer are found lying there. Accordingly I seized all the above noted articles in presence of two independent witnesses namely (1) Naresh Ch Barman (56) S/O Late Kamteshwar Barman of Uttar Netaji Para Shantinagar PS Bhaktinager Dist Jalpaiguri and (2) Ramesh Mandal (54) S/O Late Keru Mandal of do under proper seizure list with a view to take legal action as they violated the prohibition U/S- 3/ 4 of W.B.G.& P.C Act.

In this circumstances it is clear that the above noted accused persons namely (1) Ranjan Mandal (34) @ Ranjay S/O Sri Ratan Mandal of Panchanan Road, Netajipara, Uttar Shantinagar, PO- Goghomali, PS Bhaktinagar Jalpaiguri (2) Samir Das (26) S/O Lt Shyamal Das of do (3) Bhabaranjan Mandal (35) S/O Lt Souvagya Mandal of do (4) Sumit Das (27) S/O Sri Sambhu Das of Netaji Colony (Near Ambedkar Club), Ward No- 37, PO- Goghomali, PS Bhaktinagar Jalpaiguri (5) Biswajit Saha (28) S/O Sri Bablu Saha of Niranjannagar, Ward No-36, PO- Goghomali, PS Bhaktinagar Jalpaiguri (6) Babai Karmakar @ Potla (33) S/O Sri Nanda Gopal Karmakar of Arabindapally (Near Italian Math), Ward No-37, PO- Goghomali, PS Bhaktinagar Jalpaiguri and (7) Gourav Rana (26) S/O Lt Prem Rana of Paulpara, PO- Shibmandir, PS Matigara, Darjeeling violated sec - 3 / 4 of W.B G & P.C Act-1957. Accordingly I arrested them as they are violating the above mentioned section of the Acts.

Hence I pray to you that one specific case may kindly be started against the above noted accused persons and to arrange for its investigation.
