Respected Sir,

During inspection of deemed disconnected premises having OSD at different villages under Naxalbari CCC on 26.09.2022 by S & LP Team of Darjeeling Region, WBSEDCL headed by S.O, S & L.P and D.E., S & LP, along with officials from this office, one service connection in the name of Fulo Kishan in Trihanana T.G. labour line (Con ID 401645773) has been found disconnected with OSD amount Rs. 28316.00, but the specified meter having meter no. B3477299 has been found missing or removed. But another connection was found live and running in the same premises in the name of Sri Saiban Kishan, S/O Fulo Kishan having Con ID 4002340065 and Meter No. L05287921. As such, it is presumed that some mal-practice have been occurred in the premises to eliminate the record of an existing connection having huge OSD & to get a new connection by the existing owner & occupier of the premises, which is an offence under I.E. Act, 2003.

In this circumstances, the undersigned is lodging the complaint before you for proper investigation of the matter and help us accordingly for realization of the OSD from the existing owner/occupier of the premises.
