I, PSI Amit Saiba of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Sanoj Sahani (38) s/o Ram Chalitra Sahani of Rama jote, Bhujiapani PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

- 1. Ten (10) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-A in which 01 bettle taken as sample for examination exhibit-A1
- Ten (10) Ltrs Local made ID Ligher locally called as " Cholai" which kept in one Plastic Jar Marked as "Exhibit –B in which 01 Ltr taken as sample in a Plastic bottle for examination exhibit-B1.

I am subjusting a written complaint tgainst the scove noted about all person to one effect, thut today on 29.09..22 at 22-05 hrs received secrete source of information that one person was selling id Liquor illegally from his house at Rama jote, Bhujiapani to its customers without any valid license. Accordingly the duty officer of Bagdogra PS informed the matter to O.C. Bagdogra PS and as per his instruction myself along with ASI Jakirul Islam, C/1008 Kanak koy, CV- 386 Kishor Hawider CV- 389 Janak Singh, VP-01 Ansalam Kujur left for Rama jote, Bhujiapani to verify the veracity of information which noted in GD vide Bagdogra PS GDE No. 1657 dt. 29.09..22. On arrival at the spot at 22-35 hrs it was found that one person mentioned above was selling liquor and local made cholai illegally from his house at Rama jote, Bhujiapani to his designated customers to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered 1. Ten (10) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml 2. Ten (10) Ltrs Local made ID Liquor locally called as " Cholai" which kept in one Plastic Jar from his house at Rama jote, Bhujiapani from the possession of the apprehended person and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 22-55 hrs and 23-25 hrs (seizure Total approx 16 Ltrs).
