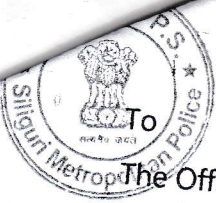

I ASI Balam Roy of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge a written complaint to the effect that today on 03.10.2022 I was performed evening Mobile duty under Bagdogra PS area vide Bagdogra GDE No. 105 dt. 03.10.22. At around 15-05 hrs received an information from duty officer that one Bus met an accident on AH-02 near Hebron School at Singhijhora, accordingly I informed the matter to O.C. Bagdogra PS and as per direction at 15-15 hrs myself alongwith force reached at the spot AH-02 near Hebron School and found that one person is lying on road with received bleeding grievous injury in unconscious condition and one Bus having registration No. WB-57-A-6197 was detained by the local people which was involved in that accident on road on AH-02 near Hebron School at Singhijhora, accordingly the Bus was taken into custody and Immediately I shifted the injured person with help of local people to Bagdogra P.S. Health Centre for treatment, but the attending Doctor declared brought dead. On enquiry it could be learnt that the name of the deceased Lakhan Barik s/o Lt. Jeet Bahar Barik of Kamalpur Godown Line under Bagdogra PS and over this written information of Doctor, Bagdogra Hospital, started Bagdogra PS UD case No. 36/22 dt. 03.10.22. As per statement of the local people it could be learnt that the said offending Bus was coming from Naxalbari side with high speed and negligent driving and dashed to the said person near Hebron School, as a result he received grievous injury and then brought dead at Bagdogra Hospital. The said vehicle got into this accident due to high speed and negligent driving of the driver of the said vehicle.

Under the above circumstances, I request to you that a specific case may kindly be registered against the driver of the vehicle bearing No. WB-57-A-6197 under proper section of law and arrange for its investigation.
