Respected Sir,

I Sirju Paswan s/o Late Rajendra Paswan residing at Baribhasha Bamswari, Sir, on the occasion of auspicious Durga Puja I have given a stall of fast food (chowmin, momo etc) at Dada Bhai sporting club of Siliguri with the help of my mother Parmila Paswan, and a staff. These three eunuchs including a man visited at stall ^{on 4.10.22 around 12:35 AM.} as a customer and after eating the chowmin they started arguing with us about the cost of chowmin per plate, after that they started to beat us, and they have beaten us brutally me and my mother. My mother is critically injured and she is admitted in Siliguri District Hospital. They have also punched on my nose, where I got stitches. However, later we have been rescued by the local committee. Sir, we have identified three Kinnes and their names are as given below:-

- (i) Rashmi Roy
D/O - Kamak Roy (Coochbihar)
- (ii) Sakshi Roy
D/O - Ratan Roy of (Dakshin Shanti Nagar)
- (iii) Mania Biswas
D/O - Late Ashok Biswas

However, we could not identify a man who was with the rimmer. He fled from there with our stall case cash amount 20,000/-.


