Dear Sir,

I, Sri Madan Mohan Thapalia, Son of Sri Shankar Thapalia, resident of Milan More, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling beg to report you that yesterday on 03.10.2022 at about 11.15 P.M. three local boys namely (1) Sahil Pradhan, Son of Narad Pradhan, (2) Sri Suraj Kami, Son of Ranjit Kami, and (3) Sri Ritesh Darjee, Son of Prakash Darjee, resident of surrounding villages of Jadubhita, Tindhurey and Karaibari respectively for all villages P.O. Chapasari, under P.S. Pradhan Nagar, Dist. Darjeeling being in intoxicated state suddenly entered in my sweets shop namely "Brindaban Sweets" at Milan More and without any reason and without any provocation from our side began to abuse me and my two employees (Karigars) using the words like "Sala Maa ka Chut" and other very filthy languages. One of my Karigar replied them not make abuse using such words. Only this much of reply of one of my Karigar made those three hooligans more furious. Thereafter, without making any further conversation two of them started to hit my Karigars with their powerful blows and kicks and one pushed me back upto wall gripping my shirt at my chest. They were also saying "you bloody outsider. You all should be driven out of Milan More area or else you should be beheaded by Khukuri." I had to struggle hard with them for saving myself and my Karigars. Due to my frequent resisting interference both of my Karigars somehow manage to escape from the shop.

Thereafter, I requested them to leave the shop as I wanted to shut my shop. But they did not allow me to do so and said that until and unless they give permission I could not shut my shop. I requested them again and again but they all stayed at shop till 1.30 A.M. of 04.10.2022 giving me different kind of threaten me again and again. They also said that they will not hesitate even to kill me at any place.

At 1.30 A.M. when they all came out of the shop in search of my Karigars I had a chance and I shut down my shop very speedily to save myself from their further daring attack.

I, therefore, humbly request you to kindly lodge the mater stated above as an F.I.R. in your P.S. and take a prompt legal action against the abovenamed hooligans so that we can leave in peace and safe.
