I Sri Nirmal Kumar Bhowmick S/O Late Krishna Gopal Bhowmick, resident of Airport More, P.O- Bagdogra, P.S- Bagdogra, Dist-Darjeeling, beg to report you the following facts:-

- 1) That I am the sole and absolute owner of land measuring 8.30 decimals or 5 Kathas mentioned in the scheduled below:-
Area-8.30 decimals or 5 Kathas Mouja-Bairatisal J.L No-70,Pargana-Patharghata L.R Khatian No-1525, R.S Plot No-339,L.R Plot No-365,P.S Matigara,Dist-Darjeeling

Boundary

North:- 12 Feet Wide Pucca Road.
South:- Sold land of Nirmal Kumar Choudhury.
East :- Land of Bimal Chandra Roy.
West :- Land of Paresh Bhowmick.

- 2) That I purchased the aforesaid land in the Year 2006 by virtue of a registered sale deed vide document no- 2061 for the year 2006, Book No-1, Volume No.52, Pages- 143 to 156, registered at A.D.S.R office, Bagdogra.

Thereafter the aforesaid Land mutated in my name in the office of the B.L and L.R.O Matigara in the mutation case No. 276/IX-II/2006 and in ROR maintained in the said office my name has been recorded in respect of my said land and a new Khatian has been opened in my name-vide Khatian No- 1525.

- 3) That the aforesaid land has been in my possession since 2006 having my right, title and interest therein.

The said land is lying vacant

- 4) That (i) Sri Bharat Roy S/O Late Haralal Roy@ Harilal Singha (ii) Sri Bharen Roy S/O Late Haralal Roy @ Harilal Singha (iii) Haren Roy@ Haren Singha S/O Late Haralal Roy@ Harilal Singha (iv) Smt. Rame @ Rama Roy W/O Sri Surath Roy and D/O Late Haralal Roy @ Harilal Singha all are of

Bharat Basty, Bairatisal, P.O-New Rangia, P.S-Matigara, Dist-Darjeeling are the big and famous land mafia of the area where my said land is situated.

They have chain racket to run their land mafia illegal trade.

They use to occupy any vacant land of any land owner (which they find by their land mafia operation) illegally and forcefully taking the advantages of temporary absence of such land owner or by putting in fear of murder to such land owner for their wrongful gain.

Thereafter they either sale such land in exchange of huge amount of money or they extort hand some amount of money from such land owner for releasing such land to them (such land owner)

- 5) That residence is at Airport more, Bagdogra, Which is 5 KM off from my said land.
- 6) That the aforesaid 4(four) persons namely Bharat Roy, Bharen Roy, Haren Roy@Haren Singha, Rame@Rama Roy with their associates entered into a criminal conspiracy to occupy my said vacant land for their such illegal Pecuniary gain.
- 7) That in pursuance of their criminal conspiracy, they illegally occupied my said land taking the advantages of my temporary absence for their such purpose.

Thereafter they sold out my said land to one Sri Ganga Yadav S/O Jallal Yadav of Tadong Bazar, Daragaon. P.O-Tadong, P.S- Sadar Police Station, Dist-East Sikkim, State-Sikkim, by showing false and fake owner of land and earned huge and handsome amount of money.

After knowing the aforesaid facts. I went to Matigara P.S for lodging FIR against them but Matigara police did not take my FIR.

- 8) That thereafter finding no other alternative, I filed a case against them in the Court of the Ld-Civil Judge, senior Division at Siliguri for relief vide T.S No- 7/2015

On 28/01/2020, the Ld. Court passed/granted decree in respect of my said land to and in my favour.

The Xerox copy of such court decree copy is enclosed herewith.

- 9) That since 2/2/2020 the aforesaid 4(four) land mafia persons including the aforesaid purchaser namely Ganga Yadav have been constantly threatening me by saying that they will murder me and my family members if I Come to my said land and claim my said land as my land and if I claim ownership of said land any time in future.

They also threatened me for not showing or placing such court decree copy to any authority.

10) That yesterday at about 4(four) P.M I went to my said land to see them. At that time aforesaid 5(five) persons restrained me from entering into my land and threatening me in same aforesaid way and manner. At that time their 5/6 associates also there and all of them v showing their muscle power said Bharat Roy showed me a pistol and one person out of the associates holding a sharpen Bhojali showed me the same and they all threatened me to go from there (from my land) otherwise they will murder me and due to fear I fled away from the
