With due respect, and in producing here with one accused namely Gaganpreet Kaur (33yrs) D/o Ramender Singh of A0204 Uttarayon Township PS Matigara Dist Darjeeling under arrest along with one vehicle bearing Reg. No. WB 74 BF 1001 and one driving License having No. WB23843B570 valid upto 03.11.2029 under seizure, I ASI Jaydeep Dutta of Bagdogra Traffic Guard, SPC would like to lodge this written complaint against the above noted Gaganpreet Kaur to the effect that today i.e 03.10.2022 at around 21:50 hrs in course of Traffic regulation duty at Uttarayon Exit gate noticed that the above noted vehicle bearing Reg. No. WB 74 BF 1001 being driven rashly by its driver proceeding towards Darjeeling more side from City centre side and the vehicle after covering few distance off tracked from the spot and found one lady in immediately I along with other force rushed to the spot and called mobile van of the driving seat was seemed to be in drunken condition. Being asked, she disclosed her identity as noted above. Subsequently being called mobile van of Matigara PS with LSI Subarna Routh and lady force arrived at the spot at Chandmoni more. Subsequently I seized the vehicle and driving license noted above and also arrested above noted Gaganpreet Kaur with the help of Lady Force after maintaining decency of the arrestee and observing all formalities for rash and negligent driving under the influence of liquor. Subsequently I produced the arrested Gaganpreet Kaur before the Medical officer at Matigara BPHC and got her medically checked up.

Under the above circumstances, I pray before your good office that a specific case under proper section of law may kindly be initiated against above noted accused namely Gaganpreet Kaur (33yrs) D/o Ramender Singh of A0204 Uttarayon Township PS Matigara Dist Darjeeling and arrange for its investigation.
