Sir,

In producing herewith 01 (one) arrested accused named Bimal Chhetri (36 yrs) S/O Gun Bahadur Chhetri of Bataliguri, Tarabari, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-

(i) 12 (Twelve) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".


I, SI Goutam Mallik of Matigara P.S. SPC would like to lodge this written complaint against the above noted arrested accused namely Bimal Chhetri (36 yrs) S/O Gun Bahadur Chhetri of Bataliguri, Tarabari, PS- Matigara, Dist.- Darjeeling to the effect that on 05.10.2022 at 18.05 hrs I received a specific source information that one Bimal Chhetri of Bataliguri, Tarabari, PS- Matigara, Dist.- Darjeeling is selling illicit liquor at his residence at Bataliguri, Tarabari under PS- Matigara, Dist.- Darjeeling. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 212 dated 05.10.22 and informed the fact to the officer-in-charge, Matigara PS and as per his kind order and direction myself along with C/974 Mintu Sen, C/374 Debraj Biswas, C/219 Sanatan Chitrakar all of Matigara PS left for Bataliguri, Tarabari under PS Matigara, Dist.- Darjeeling to work out the information in hand. After arrival at Bataliguri, Tarabari and being identified by the source we held raid at the house of Bimal Chhetri S/O Gun Bahadur Chhetri of Bataliguri, Tarabari, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and also disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned detained person named Bimal Chhetri (36 yrs) S/O Gun Bahadur Chhetri of Bataliguri, Tarabari, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 05.10.22 in between 19.15 hrs to 19.45 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused namely Bimal Chhetri (36 yrs) S/O Gun Bahadur Chhetri of Bataliguri, Tarabari, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


