solemnized on 21.05.2016, according to Hindu Rites and Customs, after
observing all formalities of a Hindu Marriage on and from the rented
house at Delhi.

It is to be mentioned here that I met with my husband
through social networking site named as Facebook and subsequently, a
friendship relation was developed amongst us and thereafter, he started
to create pressure upon me to marry him which, I have flatly refused but
day by day, he became more arrogant and reluctant with his said desire
and forced me to give my consent in marriage with him and when I
refused the same, he threatened me by saying that if I will not accept his
said proposal, he will commit suicide and at that time, I have informed
the matter before the Siliguri Police Station in the year of 2013 but he
did not change his said activities and behavior towards me and finding
no other alternative, due to the continuous pressure of my husband and
his entire family members, I have compelled to give my consent in
marriage with him without taking any permission from my parents and
subsequently, in the year of April, 2015, I have entered into the marriage
tie with my husband at the Arya Samaj Mandir, Connaught Place in
presence of my in laws members.

Thereafter, in the year of 2016, somehow, I have gathered
the courage and informed the said fact to my family members and after
knowing the said facts, my parents also organized a social marriage
ceremony on 12.06.2016. After our marriage, my husband brought me at
his house at Delhi and we have started to live and cohabited together as
husband and wife with my other in laws members.

It is very painful to mention here that immediately after
entering into my matrimonial house, my Mother-In-Law in conspiracy
with other in laws members have started to taunting me for not bringing
sufficient dowry from my parental house as per their demand. Day by
day, my husband in conspiracy with his family members have started to
dominate me in every manner and caused inhuman mental and physical
torture upon me without any just cause and reason. They treated me
just like a maid servant in their house and forced me to do all the
household works of their house as they were not at all happy with the

articles which were given by my parents to my in laws members as per their demand and they always forced me to bring more dowry from my parental house. My husband never tried to cooperate with me in any manner whatsoever and always refused to perform his matrimonial obligation making every trivial household things to an issue and I being a newly married wife, always tried my level best to discharge my matrimonial obligation towards my matrimonial life with a hope that all things will definitely be changed in near future but all my hopes have gone in vain due to the continuous inhuman torture of my husband and in laws members.

It is pertinent to mention here that in the month of November, 2016, I was diagnosed with the life threatening disease of MDR (Tuberculosis) (CAT 4) last stage and hearing the said news, my husband and his family members abandoned me and flatly refused to take any responsibility towards me and also refused to provide adequate medical and financial help to me and forced me to leave their house and finding no other alternative, in the month of December, 2016, I have compelled to take shelter at my parental house in order to save my life from the said life threatening disease and thereafter very surprisingly, neither my husband nor his family members enquired about my health condition at any point of time save and except, in the month of May, 2017, when I was admitted in the Hospital considering my critical condition.

Thereafter, I have visited at Delhi in three occasions for my treatment but it is very unfortunate that my husband neither accompanied with me to the Hospital nor even met with me and he being my legally married husband, has not incurred any single penny towards my treatment when I was battling for my life in I.C.U. and till in the month of January, 2019, I was suffering and battling with the said life threatening disease only with the help of my parents and other family members.

After recovery from the said disease, I again went to my matrimonial house with a view to lead further conjugal life with my husband happily but immediately after entering into their house, my husband and his family members have started to abuse me with filthy and abusive languages and also threatened me to leave their house immediately. In the mean time, my husband and his family members have decided to purchase a flat at Sector 44 Noida and for the purpose of registration of the said flat, my husband asked me to bring a sum of Rs. 3,00,000/- only from my parents in the year of 2018 and accordingly, for the sake of my future conjugal life, my parents have arranged the said amount and handed over the same to my husband in the year of 2018.

After receiving the said amount for the purpose of registration against the said flat, my husband in conspiracy with his family members again started to abuse me with filthy and abusive languages and behaved with me very disrespectfully and instead of that, I used to bear all such type of mental torture of my husband and in law members with a hope that they will definitely realize their own mistake but my hopes have gone into vain when they continued their said torture upon me. My husband has started to ignore me intentionally and he started to return back in the house at late night in drunken condition

and used to abuse me and my parents with filthy and abusive languages and thereafter, finding no other alternative, I called my younger brother as I was not feeling safe and secure in my matrimonial house with my husband and in laws members and finally, I have compelled to leave my matrimonial house with my younger brother and took shelter at my parental house on 16.01.2020, leaving my all the Jewelleries and other valuables at my matrimonial house and since then, I have been residing at my parental house with great starvation and during that period, my husband neither make any attempt to bring me back in my matrimonial house in order to lead further conjugal life with me nor he paid any single penny to me towards my maintenance.

Thereafter, I have filed one application Under Section - 125(1) of Cr.P.C. and also filed one application Under Section - 13(1)(i) & 13(1)(ia) of Hindu Marriage Act, 1955, against my husband, before the Court of the Hon'ble Principal Judge, District South - East, Family Court, Saket Court Complex, Delhi and my husband also put his appearance in the said cases and thereafter, my husband and his family members have started to threaten me with dire consequences and finally, I have withdrawn both the cases from the Hon'ble Court with a liberty to file a fresh application on and from my parental residential jurisdiction on 23.05.2022.

After withdrawal of the said two cases, I have received several threatening calls from different phone numbers from the voice of my husband and his family members and they have also threatened me with dire consequences by saying that if I again take any initiatives against them, they will not hesitate to ruin my life and property and receiving such type of threatening, I along with my family members have been passing our days with extreme fear and anxiety.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband and in-laws members as per the provision of law and obliged thereby.


