Respected Sir,

This is to inform you that I, Swastika Kumari currently residing at Hahimpara, Siliguri would like to state that a person namely Mithun Roy who resides at Deshbandhupara, Siliguri, near Jyotsnamoyee school. I know him personally. He is one of my cousin's friend. So, I know him since many days but I don't talk to him nor I am engaged with him socially. Only on certain occasions we meet each other. He is kind of our family friend but since very long he misbehaves with me by stalking and taunting in different languages. So, I have informed / warned him not to do such things with me. Last night me and my friends went for pandal hopping and unfortunately we met Mithun Roy at Y.M.A. Ground and as such he was intoxicated, and we had a conversation and while having conversation he touched my private part. After the incident, I shouted at him loudly that his family members came up and I said the incident he used to misbehave from very early days I said those in front of everyone. After that he

became violent and used his belt and started hitting up my friends, -then within few minutes his known person around 5-6 women along with 20-25 boys came up and without knowing anything about the said matter, they also started hitting me and my friends brutally. Then suddenly police came and rescued me from between them and took me to the police station. I was there in the ^{safe} custody till morning 12:30 pm around. Later after coming out from the police station, I am writing this humble application to bring this matter to you.

This is an humble application before the concerned authority to take necessary action upon the above mentioned matter and the mentioned name (Mithun Roy) and kindly look into the matter and take the necessary step which should be taken. The medical prescription is attached with the application.
