Sir,

With due respect, I am producing herewith one arrested accused person namely Chandana Roy (Barman) W/O Bijoy Roy of Shantipara, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

Total 15 (Fifteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)

I, PSI Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 26.09.2022 at 13.50 hrs I received a secret source information that one person namely Chandana Roy (Barman) W/O Bijoy Roy of Shantipara, P.S- NJP, Dist.- Jalpaiguri is selling I/D liquor illegally at her house at Shantipara, PS NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1458 dated 26.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, CV/824 Niru Kumar Yadav all of NJP PS, SPC left for NJP Shantipara area, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 14.15 hrs we arrived at NJP Shantipara area, and being identified by the source I held raid at the house of the said accused and managed to apprehended her. During interrogation she disclosed her identity as noted above and also disclosed that she is selling I/D liquor at her house since long for her illegal gain. On search the above noted I/D liquor recovered from her house. On demand she failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from her house. Accordingly, I seized the above noted I/D liquor from her possession under proper seizure list and arrested her under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 14.35 hrs to 15.25 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Chandana Roy (Barman) W/O Bijoy Roy of Shantipara, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
