Subject F.I.R.

Sir,

With due respect and producing herewith 01 (One) arrested accused persons namely (1) Sablu Roy (35) s/o Saubhagya Roy of Malivita, PO- Sahudangi Hat, PS- Rajganj, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated by them. :

1. One Black and Yellow color TVS NTORQ 125 Scooty without number plate having engine No.- KLO30300

1. SI Newton Biswas of NJP PS, Siliguri Police Commissionerate beg to report that on 28.09.2022 at 02:35 hrs I received an information that one stolen scooty without number plate is coming from Siliguri Side and proceed towards Milanpally side. Accordingly I informed the fact to the Officer-In Charge, NJP PS and diarized the fact in General diary vide NJP PS GDE No. 1541 dtd. 28.09.2022. Accordingly as per your kind order myself along with VP/08 Laxman Roy, VP/13 Jamirul Islam & CV/306 Biswajit Roy, CV/824 Niru Kumar Yadav all of NJP PS left for Goramore in front of TVS Showroom to work out the information in hand. At about 02:55 hrs we arrived at Goramore and started looking for the scooty and finally at about 03:35 hrs we noticed that one Black and Yellow color scooty without number plate is coming from Siliguri Side and Proceeded towards Jalpaiguri Side. We give several signal to stop the scooty but the said scooty did not stopped there and left for Jalpaiguri side in high speed violating our signal. After a hot chase at about 03:45 hrs we managed to intercept the said scooty at Sahudangi in front of crimination and apprehend the raider of the said scooty. During interrogation he disclosed his identity as noted above. On demand he failed to produce any valid documents in respect of the said scooty. After thorough interrogation he admitted his guilt and disclosed that he clandestinely received the the stolen scooty and going to Gatebazar area, Milanpally OP, under New Jalpaiguri PS, Siliguri Police Commissionerate, to sale the same to his design customer for clandestine disposal for his wrongful gain. There was sufficient reason to believe that the vehicle is stolen one. Accordingly, I seized the said vehicle under proper seizure list and arrested the above noted accused person under proper memo of arrest and observing all the formalities of arrest and brought to NJP PS. There search seizure was made in between 03:55 hrs to 04:15 hrs on 28.09.2022.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be initiated against the accused persons namely (1) Sablu Roy (35) s/o Saubhagya Roy of Malivita, PO- Sahudangi Hat, PS- Rajganj, Dist.- Jalpaiguri and others and arrange for its investigation.
