In producing herewith one accused person namely Lalbabu Das (39yrs) S/o. Lt. Bhola Das of Jamurivita PO Saliudangi Hat PS-NJP, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1. 14(Fourteen) Sealed Bottles of 60 Up Country Sprit each bottle containing 600 ML.

1. ASI Rabi Tamang of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 29.09.2022 at 17:45hrs received source information from Sahudangi that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 1005, dated 29.09.2022. Accordingly 1 informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/-975 Sawrup Basak and (2) NVF-131 Bidhan Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceed to Sahudangi to work out the information. At 18:25 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sahudangi and recovered the above noted articles from the possession of accused person namely Lalbaou Das (39yrs) S/o. Lt. Bhola Das-of-Jamurwita PO Sahudangi Hat PS-NJP, Dist-Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain and I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Ambari Falakata, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/o Lt. Narayan Sarkar of 9 no Coloney PO Kamarvita, PS NJP, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 18.35 hrs to 18:55 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witness

I therefore request you that a specific case may kindly be started against the accused person namely Lalbabu Das (39yrs) S/o. Lt. Bhola Das of Jamurivita PO Sahudangi Hat PS-NJP, Dist-Jalpaiguri under proper section of law
