Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Rahul Yadav (22) S/O Lt. Laxman Yadav of Rajauli, P.S. NJP, Dist. Jalpaiguri, (ii) Samir Mandal (18) S/O Nitta Mandal of Basbari, Thakurnagar, P.S. NJP, Dist. Jalpaiguri, (iii) Apon Das (25) S/O Bistu Das of Baribhasa, P.S. NJP, Dist. Jalapaiguri, (iv) Raju Sarkar (24) S/O Rampada Sarkar of Baribhasa, Madam Bazar, P.S. NJP, Dist. Jalapaiguri and (v) Kesto Pahan (24) S/O Menaj Pahan of Tarabari, P.S. Kharibari, Dist. Darjeeling and the following articles under seizure :

1. One iron made sharp cutting weapons called as Hasua and one Blunt Iron Rod used for breaking the Locks and One Hammer from the possession of Rahul Yadav (22) S/O Lt. Laxman Yadav of Rajauli, P.S. NJP, Dist. Jalpaiguri.
2. One iron made sharp cutting weapons called as Bhojoh and One Charger Torch Light from the possession of accused Apon Das (25) S/O Bistu Das of Baribhasa, P.S. NJP, Dist. Jalapaiguri.
3. One sharp cutting knife and one torch light and One Saw Driver from the possession of accused Raju Sarkar (24) S/O Rampada Sarkar of Baribhasa, Madam Bazar, P.S. NJP, Dist. Jalapaiguri.
4. One Iron Rod measuring 30 inch from the possession of accused Raju Sarkar (24) S/O Rampada Sarkar of Baribhasa, Madam Bazar, P.S. NJP, Dist. Jalapaiguri.
5. One iron made sharp cutting weapons called as Bhojoh from the possession of Kesto Pahan (24) S/O Menaj Pahan of Tarabari, P.S. Kharibari, Dist. Darjeeling.

1. SI Newton Biswas of NJP PS, Siliguri Police Commissionerate beg to state that on 30.09.2022 at 01:05 hrs received a secret source information that that a gang of miscreants come at backside of Amadighi Primary School, PS- NJP, Dist. Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Fulbari area. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No. 1638 dated 30.09.2022 and informed the fact to you as well as Asstt Commissioner of Police, East-II, SPC about the information. I also informed the fact to night RI Van ASI Bhai Chandra Tamang and requested them to come to backside of Amadighi Primary School to accompany with us. At 01:45 hrs, we arrived at backside of Amadighi Primary School under PS- NJP, Dist. Jalpaiguri and ambush there. After a few time RI Van officer namely ASI Bhai Chandra Tamang along with force came to near backside of Amadighi Primary School and accompany with us. At about 02:05 hrs as indicated by the source we noticed that 11/12 persons assembled in a dark place at backside of Amadighi Primary School, PS- NJP, Dist. Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 05 (five) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Fulbari area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02.35 hrs to 03.25 hrs hrs on 30.09.2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Rahul Yadav (22) S/O Lt. Laxman Yadav of Rajauli, P.S. NJP, Dist. Jalpaiguri, (ii) Samir Mandal (18) S/O Nitta Mandal of Basbari, Thakurnagar, P.S. NJP, Dist. Jalpaiguri, (iii) Apon Das (25) S/O Bistu Das of Baribhasa, P.S. NJP, Dist. Jalapaiguri, (iv) Raju Sarkar (24) S/O Rampada Sarkar of Baribhasa, Madam Bazar, P.S. NJP, Dist. Jalapaiguri and (v) Kesto Pahan (24) S/O Menaj Pahan of Tarabari, P.S. Kharibari, Dist. Darjeeling and others and arrange for its investigation.
