Sir,

With due respect, I am producing herewith the following articles under seizure.

- I. 09 (Nine) bottles of Tuborg Strong Beer each bottle containing 650 ML.
- II. 07 (Seven) bottles of Kingfisher Strong Premium Beer each bottle containing 650 ML.
- III. 03 (Three) bottles of Hayward's 5000 Beer each bottle containing 650 ML.

I, PSI Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 30.09.2022 at 22.05 hrs I received a secret source information that one person namely Badsha Majumdar (47) S/O Lt. Robin Majumdar of Babupara, P.S. Siliguri, Dist. Darjeeling is selling I/D liquor illegally at his restaurant namely Badsha Restaurant at Fulbari area under PS NJP, Dist. Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1673 dated 30.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy, all of NJP PS, SPC left for Fulbari area under PS-NJP, Dist. Jalpaiguri to work out the information in hand. At about 22.35 hrs we arrived Fulbari area, PS NJP, Dist. Jalpaiguri and being identified by the source I found the said accused person selling illegal Distilled liquor to regular customers at shop situated at Fulbari area and hold raid at his restaurant, but seeing the police party he along with customers were able to fled away. On search the above noted I/D liquor recovered from his restaurant. Accordingly, I seized the above noted I/D liquor from the restaurant under proper seizure list. The whole process of search & seizure was made in between 22.50 hrs to 23.15 hrs.

Under the above noted fact and circumstances, I therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused namely Badsha Majumdar (47) S/O Lt. Robin Majumdar of Babupara, P.S. Siliguri, Dist. Darjeeling and arrange for its investigation.
