Sir,

With due respect I **Parvin Begum** wife of **S.K. Amirul Islam** resident of Sarat Chandra Pally, Ashraf Nagar with in Siliguri Ward No.40, P.O.Haiderpara,P.S. Bhagtinagar, Dist.Jalpaiguri would like to inform that **Md.Firoj Ali**, *son of Md. Hazrat Ali* resident of Kazisaha, Dist.Murshidabad, Pin Code - 742133 having his **Aadhar Card no.266498482828** at present residing at Debidanga within P.S.Pradhan Nagar, Dist.Darjeeling in a newly constructed flat who had entered in a **LEAVE AND LICENCE AGREEMENT** executed on 15th June 2022, as a tenant to live in our house. But after his arrival with his family members he along with wife, *namely Parvin Begum* use to misbehave with me and my family members without any reason whatsoever and always use to threaten me and my family members with dire consequences. Not only with me, said **Md. Firoj Ali** and his family members use to create various problems with other tenants also. On 30th September 2022 **Md.Firoj Ali** said my husband that he will be leaving the rented house and on being enquired it was revealed that said **Md.Firoj Ali** caused serious damage on my dwelling house where said **Md.Firoj Ali** was residing. It is also revealed that the wall of the house was completely damaged and bathroom fittings and some valuables were missing. On my strong protest said **Md.Firoj Ali** threatened me by saying that he will harass me and my family members with some false plea and he will lodge complain against us before the police in order to harass us in front of the public in general. I have waited for a considerable period of time for the recovery of the bathroom fittings and some valuables for restore the damaged rented house. In spite of my repeated request **Md. Firoj Ali** did not pay any heed into the matter. At the time of leave 30th September 2022 at about 11 am approximately. I had said **Md.Firoj Ali** to compensate and return the bathroom fittings and some valuables but **Md.Firoj Ali** became violent and misbehaved with me which caused outraged by my modesty.

All the incidents took place in presence of my other tenants who also witnessed the incidents.

Considering above, it is requested that you would be kind enough to take necessary steps considering the gravity of my complain and for that I shall remain ever grateful to you .
