Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Sri Prasenjit Bose (ph no- 8250805297), S/O not known, resident of, Sidhi Royal Apartment, ITI Road, Jyoti Nagar, Ward No-41, Beside Pateswary School, Dist Jalpaiguri, P.S Bhaktinagar and Sri Pradip Kr Ghosh (Ph-9434233955), S/O not known, resident of Sidhi Royal Apartment, ITI Road, Jyoti Nagar, Ward No-41, Beside Pateswary School, Dist Jalpaiguri, P.S Bhaktinagar And other committee members of Sidhi Royal Flat Owner's Association.

Today morning on 04.10.2022, we received a No Power Docket from Siddhi Royal Apartment at around 10.47am . Our LT Van reached the site and found that the whole complex was decorated with lights for the festivities and the decorations were done with long chain rice bulbs. From where few of the chains came in contact of the distribution transformer's (315KVA) 11KV HT bushing and winding contacts, the transformer was located inside the complex for providing power to the residents of Siddhi Royal Apartments. Eventually due to heavy faults arising from the short circuit caused by the rice bulb chain, the Distribution Transformer got damaged. The transformer being the property of WBSEDCL, we incurred a financial loss of Around Rs 1,20,000/- (Rupees One Lakhs Twenty Thousand Only) Approx. On further enquiry with the residents, information was gathered that the decorative lights were put on by the apartment society namely Sidhi Royal Flat Owner's Association. And a written statement was collected on site from Sri Prasenjit Bose, Secretary regarding the same. The transformer was replaced & charged today on 04.10.2022 at around 4.50 pm.

Thus you are requested to kindly initiate an investigation against Sri Prasenjit Bose & Sri Pradip Kr Ghosh under Section 139 of the Electricity act 2003 amended on 2007 of India and all the committee members of Sidhi Royal Flat Owner's Association under Section 150 (1) of the Electricity act 2003 amended on 2007 of India.
