Das along with Dilip Das threatens  
each and everyone denies to pay him  
(Dilip Das) and beats now and present  
to the persons or person who denies  
to pay money.

Now Sir, today on the date of emergence of 1/10/2022 Sri Dilip Das asked for money from Sri Swarnup Roy B. 20000/- (Rupees Two Thousand only) and when Sri Swarnup Roy denied to pay the amount <sup>to</sup> Sri Dilip Das <sup>He</sup> with fatal arms chased him during emergence <sup>and</sup> beat him <sup>(Swarnup Roy)</sup> with his family members Vivek Das, Suraj Das, Anibal Das Polax Das and Sri Dilip Das also introduced himself as police personnel <sup>even</sup> today also when asked money from Sri Swarnup Roy and also threatens Swarnup Roy that he (Dilip Das) will arrest him by Ashnighat Police station and he also threatens that he will initiate or file a <sup>false</sup> case if anybody denies to pay money. Today all members of club who were present at that time of emergence tried to stop the Dilip Das ~~and~~ but ~~was~~ <sup>Dilip Das and</sup> his family members to beat Sri Swarnup Roy. But all is vain. Sri Dilip Das <sup>and family</sup> did not listened to them and beat him (Swarnup Roy) very rudely.
