With due respect, I am producing herewith the following articles under seizure.

- I. 09 (Nine) bottles of Tuborg Strong Beer each bottle containing 650 ML.
- II. 07 (Seven) bottles of Kingfisher Strong Premium Beer each bottle containing 650 ML.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 02.10.2022 at 02.15 hrs I received a secret source information that one person namely Sanjit Adhikari (34) S/O Sunil Adhikari of IOC road janata para, ward no- 35, PS-NJP, Dist- Jalpaiguri is selling I/D liquor illegally at his shop at IOC road under PS- NJP, Dist. Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No.50 dated 02.10.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/ 13 Jamirul Islam, CV/306 Biswajit Roy, all of NJP PS, SPC left for IOC road under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 02.35 hrs we arrived IOC road, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling Illegal Distilled liquor to regular customers at shop situated at IOC road and hold raid at his shop. but seeing the police party he along with customers were able to fled away. On search the above noted I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from the shop under proper seizure list. The whole process of search & seizure was made in between 02.55 hrs to 03.20 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour, that a specific case under proper section of law may kindly be started against the accused namely Sanjit Adhikari (34) S/O Sunil Adhikari of IOC road janata para, ward no- 35, PS-NJP, Dist- Jalpaiguri and arrange for its investigation.
