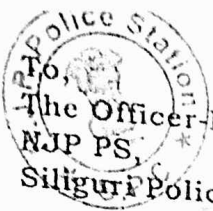

Sir,

With due respect, I am producing herewith one arrested accused person namely Biswajit Goswami (38) s/o Lt. Bimal Krishna Goswami of Jordighi, PO- Mohitnagar, PS- Kotwali, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 13 (Thirteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
2. 06 (Six) bottles of bottles of Kingfisher Strong Premium Beer each bottle containing 650 ML.

I, SI Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 03.10.2022 at 1905 hrs I received a secret source information that one person namely Biswajit Goswami (38) s/o Lt. Bimal Krishna Goswami of Jordighi, PO- Mohitnagar, PS- Kotwali, Dist.- Jalpaiguri A/P NJP Hotel Line, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at NJP Hotel Line in front of "MAA Hotel", PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 127 dated 03.10.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP 08 Laxman Roy, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Hotel Line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1915 hrs we arrived at NJP Hotel Line, and being identified by the source I held raid in front of "MAA Hotel" where the above noted accused person selling ID Liquor in front "MAA Hotel". Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at near Road Side in front of "MAA Hotel" since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1945 hrs to 2015 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Biswajit Goswami (38) s/o Lt. Bimal Krishna Goswami of Jordighi, PO- Mohitnagar, PS- Kotwali, Dist.- Jalpaiguri and arrange for its investigation.
