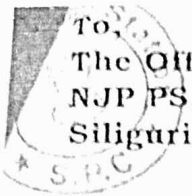

Sir,

With due respect, I am producing herewith one arrested accused person namely Rajesh Ali (34) s/o Azizur Rahaman of Pradhampara, PS NJP, Dist. Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- (i) One Red Color Tractor bearing registration No WB 71B 7578 loaded with 60 CFT of Sand

I, SI Pradeep Deyali presently attached with NJP PS under your kind control beg to state that today i.e. on 06.10.2022 at 2005 hrs. I received a secret source information that one Tractor bearing registration No WB 71B 7578 loaded with Sand coming from Radhabari near BSF Camp and Proceeded towards Jatiyakali, Nipaniya for its clandestine disposal. Accordingly I diarised the fact in the General Diary vide New Jalpaiguri PS GDE No 265 date:06.10.2022 and also informed the matter to Officer In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate. As per kind direction and instruction of Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate myself along with force namely ASI Sajal Das, VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for Jatiyakali More, PS NJP, Dist. Jalpaiguri to verify the verisity of the information. At about 2025 hrs myself along with Officer & force arrived at Jatiyakali More, under New Jalpaiguri PS, SPC and ambush in front of Petrol Pump. At about 2035 hrs we saw one Red Color Tractor loaded with Sand without number plate coming from Radhabari Side and Proceeded towards Jatiyakali. I signalled the driver of the said Tractor to stop the Tractor but ignoring our Signal he persistently proceeed towards Jatiyakali. After we chase the said Tractor we successfully intercept the said tractor at Jatiyakali More in front Fulbari High School. On being asked the driver of the said Tractor disclosed his name and address as noted above. On demand he failed to produce any valid documents regarding the possession of sand loaded at Tractor as well as failed to provide any valid documents of the Tractor. On further interrogation he disclosed that he illegally taken the sand from Sahu river in opposite side of BSF Camp, Radhabari and proceeded towards Jatiyakali, Nipaniya for clandestine disposal of the same. That there is sufficient reason to believe that the above noted Driver have stolen those sand from Sahu River with any Legal Royalty/Paper as per rules, for selling Clandestinely. Accordingly, I seized the said Tractor bearing registration No WB 71B 7578 loaded with 60 CFT of sand after issuing proper Seizure list and arrest the accused person after issuing proper Memo of Arrest and observing all the gudline issued by the Apex Court. The whole process of search & seizure was made in between 2055 hrs to 2125 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Rajesh Ali (34) s/o Azizur Rahaman of Pradhampara, PS-NJP, Dist.-Jalpaiguri and arrange for its investigation.
