SUBJECT - F.I.R. against SMT. PRATIMA GHOSH, SMT. TOMPY GHOSH @ MAYA GHOSH and MR. MUNNA GHOSH

Respected Sir,

I, SMT. PRIYANKA GHOSH, wife of Late Nayan Ghosh @ Narayan Ghosh, housewife by occupation, residing at Rupsingh Jote, Post Office & Police Station Bagdogra, District Darjeeling, Pin-734014, in the State of West Bengal, INDIA, would like to state as follows:-

1. That my husband was the owner of the grocery shop. My husband Nayan Ghosh @ Narayan Ghosh died on 16-11-2020 leaving me, my minor son namely Bubai Ghosh & my mother-in-law namely Smt. Pratima Ghosh as his Legal Heirs. After demise of my husband on request of my sister-in-law namely SMT. TOMPY GHOSH @ MAYA GHOSH, W/o. Sri Dulal Ghosh and her son namely MR. MUNNA GHOSH, W/o. Sri Dulal Ghosh permanent resident of Balurghat, Basanta, P.O. & P.S. Hili, District Uttar Dinajpur, I gave the shop to them on a lease basis. At the time of handing over the shop there was grocery items worth about Rs.8,00,000/- (Rupees Eight Lakhs only). At the time of taking the shop they promised to give me Rs.5000/- (Rupees Five Thousand only) per month.

That since last six months they have stopped paying me the amount. Whenever my son or I went to take some grocery items from the shop they refused to give the same.

3. Yesterday i.e. on 07-10-2022 at about 4.30 P.M. when I went and requested them to pay the outstanding amount they harshly refused to give the same and started using foul language at me. Thereafter I took possession of my shoproom and locked the shoproom. While I was locking the shoproom they called my Mother-In-Law and my mother-in-law came and tried to stop me from locking the shoproom. At that time she slipped and sustained injury in her hand.

4. That after I handed over the shop SMT. PRATIMA GHOSH, SMT. TOMPY GHOSH @ MAYA GHOSH and MR. MUNNA GHOSH started physically & mentally harassing me to either bring money from my parents or leave my husband's house. This has been their regular habit of torturing me for want of money. Yesterday i.e. on 07-10-2022 at about 5.00 P.M. they all again came to my room and physically assaulted me to handover the keys of the shoproom. Due to their physical assault I sustained injury in my leg and hand. When I shouted they all left the room.
5. They are very clever and since they came here to reside they started creating a problem. Their main intention is to anyhow throw me & my son out of my husband's house and forcefully occupy the full property of my husband including the shop.
6. I was shocked to see that my mother-in-law supported SMT. TOMPY GHOSH @ MAYA GHOSH & MR. MUNNA GHOSH in this shameful act. The whole plan was cooked by SMT. TOMPY GHOSH @ MAYA GHOSH & MR. MUNNA GHOSH so that I leave my husband's house and they could enjoy the property of my husband.
7. SMT. TOMPY GHOSH @ MAYA GHOSH & MR. MUNNA GHOSH are very ill behaviour and ill mannered person and they even were using very filthy language at me and my minor son. They even threatened me that if I lodge any FIR or Complaint before Police Station they will kidnap my son.
8. That after demise of my husband there is no one to look after of me and my minor son and taking advantage of this SMT. TOMPY GHOSH @ MAYA GHOSH & MR. MUNNA GHOSH & my mother-in-law SMT. PRATIMA GHOSH are doing such shameful act day after day.

It is requested before you to kindly take necessary strict action against MR. MUNNA GHOSH, SMT. TOMPY GHOSH @ MAYA GHOSH and SMT. PRATIMA GHOSH so that I can stay in my husband's house peacefully with my minor son and also they can be stopped from harassing me and I can get justice.
