Subject: Physical and Mental torture by Husband.

Sir,

I, Bornali Das, daughter of Nabajyoti Das, permanent Resident of Milonpur, Khuti Katia, Nagaon, Assam, do hereby like to inform you that, I met Mr. Sadhan alias Biltu Mishtri, Son of Ranjit Mishtri three months before at my work place, we fell in love so quickly and he took me to his hometown at Bongaon at his parent's home for marrying me. The very next day on 04/08/2022, we got married to a nearby temple from his house before his family members. Everything was normal for 5-6 days, then I got to know about his previous marriage, and suddenly his behaviour got completely changed towards me, he started to beat me in front of everyone of his family, and also started torturing me sexually. Approximately after 15 days he took me back to Siliguri where he used to stay for his work purpose at Near Shivmangal school, Ward No. 41, Siliguri, District- Jalpaiguri. After getting back to Siliguri, I got to know about that I am pregnant with his child, knowing this he went furious and as a result I lost my child. After that his tortures became intolerable for me, and I flew back to my hometown Nagaon for saving my life from his inhuman tortures. Then he went to my hometown to took me back, but my family members informed the local police about him, where he got arrested initially, but he convinced me before the police to came back with him to Siliguri, he assured me to set me free after lawful settlement. After we came back to Siliguri staying here for few days, I went to Bhubaneshwar for my work purpose. But now he is constantly threatening me over call that he will destroy my life, he even disturbs my work people. He uses the worst language on my character whenever we talk over call, threatens to spread my private photos and videos whichever he have with him, and threatens to kill me. I just came back to siliguri without his knowledge to just make a complaint against him and currently staying in a hotel.

So, Sir, it's my request to you to get him as early as possible to punish him for falsely making me to fall into his trap, torturing me inhumanly, threatening my life, making my life miserable, so that this can ensure my safety and I can freely roam around and work independently without any fear.
