In producing here with the seized articles viz:-

- (i) 05 (five) no's Indane domestic Gas Cylinder partially loaded
- (ii) 01 (one) gas pipe length about 04 (four) ft with fitted one gas Regulator
- (iii) 01 (one) iron gas oven

Under proper seizure list. I SI Goutam Kundu of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against the owner namely Papon Sarkar (40yrs) S/O Lt. Niranjan Sarkar of Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling owner of "Sarkar Sweets" located at Jyotinagar main Road, Near Jhankar More PS- Siliguri Dist- Darjeeling who was illegally procured the domestic Gas cylinder at his sweet shop styled as "Sarkar Sweets" for commercial purpose without any valid documents or licence to the effect that today i.e. 11.10.22 at about 12.15 hrs received an information from reliable source that above noted Sweet Shop styled as "Sarkar Sweets" situated at above mentioned address using the domestic Gas cylinder at his sweet shop for using commercial purpose for wrongful gain.

Accordingly, the matter informed to ACP EB SPC and as per his direction I, along with, SI Pradip Chakraborty, ASI Ashoke Biswas, C/424 Manik Roy, C/924 Avijit Kar all of EB SPC with investigation kit left for Siliguri PS area vide EB SPC C.C No 162/22 Dt. 11.10.2022. The matter informed to Siliguri PS for providing police assistance vide Siliguri PS GDE No. 565 dated 11/10/22. At 12:30 hrs and accompanied with Officer and forces ASI Rabin Lama, C/1186- A. Minj, HG 479 Shambhu Kamti of Van K-21 vide MCC NO 1777/22 Dated 11/10/2022 had been to Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source information we reached and entered into the Sweet Shop cum workshop styled as "Sarkar Sweets" situated at Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling. During search found worker of sweet shop making sweets items by using the domestic Indane Gas cylinder without any valid documents for commercial purpose. On demand they failed to produce any valid documents in support of using the Indane domestic gas cylinders in the workshop of said sweet shop for commercial purpose. Further local enquiry it revealed that the above noted sweetshops owner noted above is using the domestic gas cylinder for preparing Sweet Items at the sweet shop for commercial purpose in order to wrongful gain without any valid document. I also invited two independent witnesses namely (1) Sumit Ghosh (18yrs) S/O Dipu Ghosh C/O Sarkar Sweets Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling (2) C/924 Avijit Kar of EB SPC.

During further local enquiry it could be learnt that the Sweetshop owner namely Papon Sarkar owner of "SARKAR SWEETS" of Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling using the domestic gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from his Sweetshop styled as "SARKAR SWEETS", staff of the Sweetshop unable to produce any supporting documents for using domestic gas cylinder at their Sweetshop for commercial purpose. I Seized the articles noted above from the Sweetshop after preparing proper seizure list and label in the presence of witnesses noted above. The seizure was made in between 13.15 hrs to 13.35 hrs. But found the owner of Sweetshop Papon Sarkar absconded from the shop to evade police arrest to seeing the police party.

Hence, I pray that a specific case may kindly be started under section 285, IPC r/w 7(i)(a)(b)(c) of Essential Commodities Act 1955 against the accused person namely Papon Sarkar S/O Lt. Niranjan Sarkar of Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling owner of Sweet Shop Styled as "SARKAR SWEETS" situated at Jyotinagar main road, Near Jhankar More PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
