## RESPECT SIR,

I Anjali Sahani, Wife of Subhash Sahani, resident of Baghajatin Colony, Ward No. 45 of SMC, Police Station and Post Office - Pradhan Nagar, District - Darjeeling, beg to report you the following facts:-

- 1. That my marriage was solemnized on 22.04.2021 with Subhash Sahani, Son of Hari Sahani of Baghajatin Colony, Ward No. 45 of SMC, Police Station and Post Office - Pradhan Nagar, District - Darjeeling, according to Hindu rites and customs and at the time of marriage my husband and in laws took cash Rs.. 3.00,000/- and gold ornaments worth Rs. 5,00,000 from my parents as dowry.
- 2. That soon after marriage my husband and my father in law namely Hari Sahani, mother in laws namely Fuleswari Devi and brother in law Sushil Sahani started to torture me both physically and mentally. They used to ask me to bring more cash Rs. 3,00,000 from my father's house and when I did not fulfil their such demand their torture upon me increased rapidly day by day. Thereafter, in the month of July 2021, they send me to my parents home at Assam and told that until and under I do not fulfil their such demand they will not keep me in my in

Finding no other alternative and seeing my future anyhow my parents managed Rs. 2,00,000 and gave Rs. 2,00,000 on 05/07/2022 to my husband and in laws and then they allowed me to enter into my in laws home. But even after that their torture upon me did not stop. They made me to do all household work whole day long and always kept me locked in room so that I cannot talk to anyone. Even they did not provided me any medical treatment whenever I used to get ill. However my brother in law Sushil Sahani kept bad eye upon me and tried to molest me and even entered in my room and made bad sign and told me that if I accept his proposal and treat-him like his husband all torture upon me will be stopped and when I complained about the matter to my husband and mother in law at that time they oppositely started to beat me mercilessly and told that I have been falsely implicating my brother in law.

In the meantime I became pregnant and knowing their fact my husband and especially mother in law started to pressurize me to about my said child saying that there will be medical expenses in the delivery of child and they will not bear the same and if I have to keep my child then told to bring further Rs. 5,00,000 from my father home for my treatment till delivery and when I depied my husband brought me some medicine and told to consume it so that my child will be aborted and on my denial assaulted me mercilessly.

Since then my husband and mother in law has been continuously torturing me and assaulting me almost every day for aborting my child and on 7.10.2022 at: about 6 pm my husband and mother in law started to assault me and forcefully put medicine in my mouth and told me to swallow it but I split it out. Then my husband and mother in law poured kerosene oil on my body and tried to burn me but anyhow I saved myself and went out of the house and cried for help but none came to help and I tried walking on the road lonely as I do not know any place of Siliguri area then one of the relatives of my father saw me and took shelter at his home at Dharamnagar, Pradhan Nagar. They had also snatched my mobile phone so that I could not contact with my family members.

Anyhow my husband came to know about my whereabouts and on 8.10.22 my husband and mother in law, brother in law and father in law came at his home and started to assault me and forcefully tried to take me with them with intention to kill me at my in laws home so resisted to go there. Then they tried to strangulated me and they forcefully made me to say that I have left my in laws voluntarily and staying at my relatives home and recorded the same in their mobile phone. They even assaulted my uncle who had given me shelter and told that if he reposted the matter to anyone then he would kill him and even told him to drive me out from their home otherwise he will have to face dire consequences.

- 3. That out of fear of my in laws and husband I would not get out of the home and lodge complain at police station.
- 4. That my parents came today from Assam and as such I am lodging this FIR today. So delay may kindly be condoned.
  - I, therefore request you to kindly take necessary legal action against the aforesaid culprit for the post commission of the aforesaid offence by them upor
