Sir,

In producing herewith the 02 (Two) accused persons namely (1) Sukhendu Basak (37) S/O- Lt. Manindra Mohan Basak of Hakimpara, Khela Ghar More, Ward No. 17, PS- Siliguri, Dist- Darjeeling (2) Ramesh Tiwari (53) S/O Lt. Lal Mohan Tiwari of Heiderpara, Near Haripal More, Ward No. 39, PS- Bhaktinagar, Dist- Jalpaiguri along with original seizure list.

I SI Rana Brahma of Panitanki TOP, under Siliguri PS lodged a written complaint against the above noted accused persons to the effect that today 13.10.22 at 18:55 hrs received information that a gambling was going on inside of roof shade under construction building beside Bidhan Road opposite Kanchanjungha Stadium, Siliguri. Accordingly I informed the matter to O.C. Panitanki TOP, Under Siliguri PS and diarized the fact vide Panitanki TOP GDE No. 261 dated- 13.10.22. As per his kind direction myself along with ASI Mantu Dey, ASI- Biswajit Ghosh, Const-1036 Gopal Srivastav, CV-1009 Manoj Thakur all of Panitanki TOP left for the spot to verify the veracity of information vide Panitanki TOP G.D.E.No. 262 dated- 13.10.22. On the way I called two persons namely (i) Pranab Saha (46) S/O Lt. Nirmal Saha of Kali Saha More, Chayanpara, Ward No. 37, PS- Bhaktinagar, Dist- Jalpaiguri (ii) Rakesh Singh (31) S/O-Lt. Uttam Singh of Salugara, Near Salugara Bazar, Ward No. 41, PS- Bhaktinagar, Dist- Jalpaiguri and requested them to present as witnesses during search and seizure if any, they agreed to accompanying us. On reaching the spot found that the above noted accused persons along with others were playing gambling with the help of Playing Cards by exchange of money for wrongful gain and wrongful loss to each other. Seeing the Police party they try to flee away from the spot but on hot chased Police party apprehended the above noted accused persons. On being asked they disclosed their identity as (1) Sukhendu Basak (37) S/O- Lt. Manindra Mohan Basak of Hakimpara, Khela Ghar More, Ward No. 17, PS- Siliguri, Dist- Darjeeling (2) Ramesh Tiwari (53) S/O Lt. Lal Mohan Tiwari of Heiderpara, Near Haripal More, Ward No. 39, PS- Bhaktinagar, Dist- Jalpaiguri and others fled away from the spot. On being searched at the spot : (1) Cash Rs. 13320/- (as Board money) (2) 52 Nos of Playing Cards (3) One old plastic sheet (4) 05 pices of burn candles and (5) One Mobile phone (Redmi 8A Dual Android set having IMEI No. 864474043021973/ 864474043021981) (6) one black colour LAVA key pad mobile having IMEI No. 911611002043851/ 911611002043856 are found lying at the gambling board. Accordingly I in presence above noted independent witnesses I seized the above noted articles observing signature of the witnesses as well as accused persons under proper seizure list and arrested them after issuing Memo of arrest for violating the prohibition U/S- 3/4 of W.B.G. & P.C Act. Search and seizure was made on 13.10.22 between 19:40 hrs and 20:55 hrs.

Under this circumstances I request before your kind honour a specific case may kindly be registered against the accused persons namely (1) Sukhendu Basak (37) S/O- Lt. Manindra Mohan Basak of Hakimpara, Khela Ghar More, Ward No. 17, PS- Siliguri, Dist- Darjeeling (2) Ramesh Tiwari (53) S/O Lt. Lal Mohan Tiwari of Heiderpara, Near Haripal More, Ward No. 39, PS- Bhaktinagar, Dist- Jalpaiguri and arrange for investigation.
