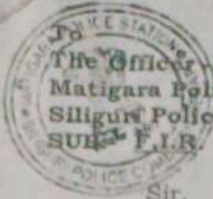

Sir,

In producing herewith 01 (one) arrested accused named Monoj Das (60 yrs) S/O Late Jiten Das of Ramkrishna Colony, Road No -03, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-

(i) 13 (Thirteen) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 ml in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, PSI Sekhar Adhikary of Matigara P.S. SPC would like to lodge this written complaint against the above noted arrested accused namely Monoj Das (60 yrs) S/O late Jiten Das of Ramkrishna Colony, Road No -03, PS- Matigara, Dist.- Darjeeling to the effect that on 14.10.22 at 22.50 hrs I received a specific source information that one Monoj Das of Ramkrishna Colony, Road No -03, PS- Matigara, Dist.- Darjeeling is selling illicit liquor at his residence at Ramkrishna Colony under PS- Matigara, Dist.- Darjeeling. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 684 dated 14.10.22 and informed the fact to the officer-in-charge, Matigara PS and as per his kind order and direction myself along with C/1053 Paresh Rava, C/374 Debraj Biswas, C/219 Sanatan Chitrakar all of Matigara PS left for new Colony under PS Matigara, Dist.- Darjeeling to work out the information in hand. After arrival at Ramkrishna Colony and being identified by the source we held raid at the house of Monoj Das (60 yrs) S/O Late Jiten Das of Ramkrishna Colony, Road No -03, PS- Matigara, Dist.- Darjeeling and managed to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. On further being searched the above noted seized articles were recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned detained person named Monoj Das (60 yrs) S/O Late Jiten Das of Ramkrishna Colony, Road No -03, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 14.10.22 in between 23.25 hrs to 23.55 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused namely Monoj Das (60 yrs) S/O Late Jiten Das of Ramkrishna Colony, Road No -03, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
