Sir,

With due respect, I am producing herewith the following seized articles as per proper seizure list viz:-

1. One iron made improvised single shutter Firearm having its trigger, hammer and firing pin measuring approx 8.15 inches including its butt, body and barrel and marked as "Exhibit-A".
2. One iron made improvised single shutter Firearm having its trigger, hammer and firing pin measuring approx 8.10 inches including its butt, body and barrel and marked as "Exhibit-B".
3. One iron made sophisticated improvised Firearm having its trigger, hammer, firing pin and magazine measuring approx 8 inches including its butt, body and barrel wherein engraved as "765 7 round made in USA" and marked as "Exhibit-C".
4. One iron made sophisticated improvised Firearm having its trigger, hammer, firing pin and magazine measuring approx 8 inches including its butt, body and barrel wherein engraved as "made in USA" and marked as "Exhibit-D".
5. One basic keypad Samsung mobile phone having its IMEI No - 351895248523811, along with inserted SIM card of Airtel, 128K SI No- 0921 ID 8991000905707707982U and Mobile No. 7393859676.

I, SI Benoy Kumar Tamang of Pradhannagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint to the effect that today on 13.10.2022 at 17.50 hrs while myself along with C/830 Pradip Roy and C/880 Shyamal Dutta were performing evening mobile duty vide Pradhannagar P.S. M.C.C. No- 2034/22 date 13.10.2022 and Pradhannagar P.S. G.D.E. No-674 date 13/10/2022, I received an information from on duty officer SI Youel Lepcha that, S.I. Bhaskar Kar of Siliguri Junction Traffic Guard informed him that two bags are lying abandoned condition behind Traffic Booth in front of Siliguri Tenzing Norgey Bus Terminus and this refers to Pradhannagar P.S. G.D.E. No- 684 date 13/10/2022. Accordingly myself along with force arrived at the Spot and I found that the two bags are laying abandoned condition behind Traffic Booth since couple of houses and nobody turned up as a claimant of the

bags. Thereafter, I called two independent witnesses namely (1) Mehedi Hassan S/O- Late Nadir Sha of Nimtala Gurung Busty, Ward No-3, PS- Pradhannagar, Dist-Darjeeling and (2) Sachin Mukhia S/O- Sanjeev Mukhia of Cooliepara near Hanuman Mandir, Ward No -1, PS- Pradhannagar, Dist-Darjeeling who were available at the spot and in presence of the said independent witnesses I searched both bags thoroughly and recovered two numbers of firearms from camouflage backpack and two numbers of firearms from red and grey colour backpack. On thorough searching I also recovered one coloured copy of Aadhar Card bearing No-241983716354 in the name of Surendra Pal, S/O- Ram Chandra Pal of 246 Chandpur, Salori, Allahabad, Uttar Pradesh-211004 (Not Verified) and others and one basic keypad Samsung mobile phone. Accordingly I seized and labeled the above noted articles at the spot under proper seizure list duly signed by above noted independent witnesses in between 18:25 hrs to 19:15 hrs. It is crystal clear from the seizure of four improvised fire arms that the fire arms being carried by unknown miscreants for committing any heinous crime or illegal act in Siliguri or trade of fire arms illegally.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started over the incident and arrange for its investigation.
