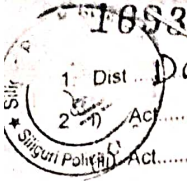

3. That I also wanted a key of the main gate but they do not provide me the key
4. That my brother in law hereinafter Arun Basak and Balai Basak torture upon me they try to grab my house and 12.10.2022 at 9 PM they slap on my head and they tear off my clothes and i Soughting for help nobody come forward to help me out.

I, therefore request to you sir please immediately take leagl action against the culprits.
