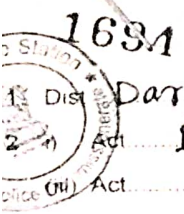

I, Smt. DebKala Das (45), the above named complainant, beg to inform you that, on dt. 13.10.22 at about 07.30 pm, when I tried to stop the gambling, playing at R. in front of my house at Santoshi Nugas, by, the above noted alleged person namely, (1) Roshan Mondal s/o Lt. Devanand Mondal of same locality and his associates, than he started abusing me in filthy languages and when my son namely, Rajesh Kumar Das (27) s/o Lt. Bhola Das, came and interfere into the matter than the mother of said alleged person namely (1) Smt. Manju Mondal w/o Lt. Devanand Mondal also came there and they both attacked on my said son, with sharp cutting deadly weapon and my son, Rajesh Kumar Das, received severe injury on his person and immediately shifted to Siliguri Hospital and admitted there, and thereafter referred to North Bengal Medical College for better treatment, they and presently fighting with life & death at North Bengal Medical College.

Sir, the above named alleged person namely Roshan Mondal, used to keep Gambling Board in the locality and many antisocial used to come there regularly & used to gamble in intoxicated condition, and Manju Mondal support them.

So, please take necessary action against said son & his mother, noted above.
