Sir,

With due respect, producing herewith one arrested accused person namely Deebyajit Kar (28yrs) S/o- Debabrata Kar of Rishi Arabinda Road Hakimpara, W/no- 12, PS- Siliguri, Dist- Darjeeling following seized fireworks /fire crackers under proper seizure list viz:

1) One white coloured cartoon box in which 120 box of fire crackers and in every box 30 pieces of firecrackers is stored, total $120 \times 30 = 3600$ pieces fire crackers named and styled as "Kung Fu" which in non- green, banned fire crackers/fireworks weight approx 15 kgs.

I, ASI Debasish Das of Siliguri P.S under Siliguri Police Commissionerate do hereby lodged complaint against the above noted accused person to the effect that on 15-10-2022 at 15:15hrs receive source information that one Deebyajit Kar has stored and selling the illegal fire crackers at his Shop styled as "Kar Enterprise" at Alupatty under Siliguri PS without any valid lisenec. Accordingly I informed the matter to I/C Siliguri PS and as per his kind order myself along with ASI Subir Sen, ASI Siben Sarkar, CV/283 Prasenjit Dey, CV/622 Ramanath Barman left Siliguri P.S vide Siliguri P.S GDE no- 807 Dated: 15.10.2022.

After arrival at Alupatty and as indicated by the source we conducted held raid against selling/storing of illegal fire crackers/ fireworks in the shop of Deebyajit Kar at Alupatty as there was secret source information that he had been storing and selling the fire crackers beyond permissible sound limit illegally to his customers. During raid apprehended one person who on being asked identified himself as Deebyajit Kar (28yrs) S/o- Debabrata Kar of Rishi Arabinda Road Hakimpara, W/no- 12, PS- Siliguri, Dist- Darjeeling and found him possessing above noted seized fire crackers kept concealed in his shop styled as "Kar Enterprise"

On being asked Deebyajit Kar admitted his guilt of purchasing, storing and selling of fire crackers at his Shop without lisenec. He also unable produce any documents in respect of storing and selling huge amount of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at this shop. The said stored fire crackers are combustibile in nature and endanger to human life and property. So, I seized the fire crackers, under proper seizure list duly signed by the witnesses. The whole process of seizure was made in between 15:50 hrs to 16:35 hrs. & arrested him accordingly.

Hence, I pray before you that a specific case may kindly be started against the arrested accused person namely Deebyajit Kar (28yrs) S/o- Debabrata Kar of Rishi Arabinda Road Hakimpara, W/no- 12, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigation
