I, **Bhawani Sha**, daughter of Sambhu Sha of Samar Nagar, Bartala, P.O. Champasari, P.S. Pradhan Nagar, Dist-Darjeeling, would like to inform/complain that as follows:-

I) That on dated 12-10-2022 near about 8:30 pm some person namely 1. Mohan Chakraborty 2. Manoj Chakraborty 3. Rahul Kodaliya 4. Ranjit Kodaliya all are resident of Samar Nagar, Bartala, P.S. Pradhan Nagar forcefully attacked on me at way of my house when I was return back along with my son namely Akshit Kr Gupta from his toughtion they all accused person started to beat me and my Son severally used slang language and uses criminal force to me and forcefully outrage my modesty, they have also snatched my Golden Mangalsutra of Rupees 1,10,000/- (One lakh Ten Thousand) Only but in the mean time some other people reached at the incident place and save me and my Son's life and they all gone out from there.

II) That Sir they all accused person threatened me if I will go to police they will sure kill me along with my son at any cost. They are chasing to my son they also threatened me that they can sure kidnap to my son (minor) so I am passing my days in very difficulties.

III) That Sir I am very much afraid about all this activity which was performed by manoj chakraborty and his associates I have to leave my above noted residence for saving me and my Son's life. That the aforesaid accused are very dangerous in nature and their activities are illegal so how can I survive at the same residence along with my Son's.

IV) That Sir conclusively my son was having sever pain in his chest resulting I went to Siliguri district hospital for treatment my son admitted and yesterday my son discharge from hospital.

So, therefore I request you to please take all necessary legal steps against. 1. Mohan Chakraborty 2. Manoj Chakraborty 3. Rahul Kodaliya and Ranjit Kadaliya to protect me and son life.
