1. That I am the registered Parking Collector of Siliguri Municipal Corporation, Parking Zone No.24 at Megnath Saha Sarani, Near North Bengal Clinic Ward No.2 of SMC, P.S. Pradhan Nagar, Siliguri, Distt. Darjeeling and my firm name is "M/S Janaki Electrical".

That toady dated 14-10-2022 in the evening at about 6.30 p.m. one person namely Bapi Gupta S/o Sri Ganesh Prasad Gupta, residence of beside North Bengal Clinic, Netaji Club Road, Ward No.2 of SMC, P.S. Pradhan Nagar, Siliguri came at my parking area and demanded extortion as Rangdari Tax amount Rs.30,000/- (Rupees Thirty Thousand) immediate from me for the said Parking area if I continue when I defended then Bapi Gupta using in slang languages immediate Slapped me and said if I will not fulfilment his aforesaid demanded amount then I as per his threatening word immediate leave the aforesaid Parking premises because this is his area if I will continue then he will not hesitate to dire consequences against me. Mr. Bapi Gupta has also threaten me from his mobile vide Mobile No.9832017463.

So, under the above circumstance I and my family member are fear because I am every time due to my said work purpose live outside from my home, therefore request you kindly enquire the matter and immediate arrest the accused Mr. Bapi Gupta as per provision of law. For this I shall always oblige you.
