Respected Sir,

I, SRI PRITAM SINGHA, Son of Sri Parimal Singha, resident of Shaktigarh Road No. 8, Ward No. 31 of SMC, P.O. Siliguri Bazaar, P.S. NJP, Dist. Jalpaiguri would like to draw your kind attention that yesterday i.e. on 13-10-2022 at around 8.30 PM when I along with my friend namely Sri Anit Das, Son of Jatindra Mohan Das, resident of Loknath Sarani, Ward No. 32 of SMC, P.S. NJP, Dist. Jalpaiguri were standing near to Central Bank of India ATM counter, 12-13 unknown miscreants without any words and/or reason attacked upon my said friend with kicks and fists. When I tried to save him from such brutal attack, the said unknown miscreants also physically assaulted me. They addressed filthy languages to us and without having no other alternative, When I shouted for help then the above miscreants fled away from the spot and it is to be referred that the said miscreants did not have any vehicle with them. Out of the said attack, my said friend got severe serious bodily injuries amounting to left leg fracture, I got severe bodily injuries (Medical papers are enclosed herewith). It seems that the above miscreants did such act under preplanned conspiring manner and there may be CCTVs as installed in such vicinity from where the miscreants can be identified. It is to be mentioned that my above friend is under serious condition right now admitted at Sanjibani Nursing Home and I being received with severe bodily injury, as per advice of the Doctor took bed rest and out of mental agony could not able to lodge the complaint on last night and now under stable health came before your very end to lodge so.

So it is therefore requested to treat the complaint as FIR and initiate a specific case for taking up a thorough investigation of the above incident and prosecute the unknown miscreants for the proper administration of Justice.
