3. 03 (three) pouches of Officer Choice Deluxe Whiskey each bottle containing 180ml.

I, SI- Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 16.10.2022 at 22.05 hrs I received a secret source information that one person namely Dilip Singh (34) S/O Lt. mahendra Singh of Coolie Para, Rajendranagar, W/No. 01, P.S- Pradhannagar, Dist.- Darjeeling is selling ID liquor illegally at "Ratan Hotel" at NJP Hotel Line, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 751 dated 16.10.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Hotel Line, PS- NJP, Dist .- Jalpaiguri to work out the information in hand. At about 22.35 hrs we arrived at NJP Hotel Line, and being identified by the source I held raid in front of "Ratan Hotel" where the above noted accused person selling ID Liquior .
