With due respect, I am producing herewith one arrested person namely Kanaiya Bhagat (35yrs) S/o- Baidnath Bhagat of Sukanta Sarani, Milanpally, w/no- 26, PS- Siliguri, Darjeeling along with following seized fireworks /fire crackers under proper seizure list viz:

- 1. Two hundred and five pieces (205) pieces of FUNUSE styled as "Sky Lantern"
- 2. One hundred sixty (160) packets of "CHAMPION BAPPA styled as "RED GREEN WHITE" each packet containing ten (10) Pieces, total 160 X 10 = 1600 pieces.
- 3. Three hundred sixty (360) packets "MAA TARA'S ELECTRIC SPARKLERS" each packet containing ten (10) Pieces, total 360 X 10 = 3600 pieces.
- Eighty Packets (80) packets of JUM JUMI CHAKKAR SPECIAL each packet containing ten
 pieces total 80 X 10 = 800 pieces

I ASI Debasish Das of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on 19-10-2022 at 18:55hrs while performing Plain Cloth duty at PS Jurisdiction receive a source information at that one person has been selling/storing huge quantity of fire crackers/fireworks at his shop at Mahabhirsthan, Khalpara under Siliguri PS. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S vide Siliguri P.S GDE no- 1023 Dated: 19.10.2022 myself along with ASI Siben Sarkar, ASI Subir Sen, Cv/283 Prasenjit Dey and CV/622 Ramanath Barman conducted raid at the shop of Kanaiya at Mahabhirsthan, Khalpara under Siliguri PS as there was secret source information that they had been selling/storing fire crackers/fireworks of beyond permissible sound limit illegally. During raid apprehended one person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers which was kept concealed at his shop.

On being asked Kanaiya Bhagat admitted his guilt of purchasing, storing and selling of fire crackers at his Shop without license. He also could not produce any documents in respect of huge quantity of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at his shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. The total quantity of Fire crackers/ fireworks is Sixty-five (65) kgs of weight amounting Rs 35000/- approx. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure was made in between 19:35 hrs to 21:15 hrs

Hence, I pray before you that a specific case may kindly be started against the person namely Kanaiya Bhagat (35yrs) S/o- Baidnath Bhagat of Sukanta Sarani, Milanpally, w/no- 26, PS- Siliguri, Darjeeling under proper section of law and arrange for its investigation.
