In producing herewith one accused person namely Gouranga Chakraborty (M/52) S/O Lt Subol Chakraborty of Bidya Chakra Colony, ward No. 44, PS Bhakti Nagar, Dist. Jalpaiguri under arrest along with following seized Firecracker (Non green)

- 1) 11 Packet of Kaniskar Fatka Fire Crackers made by Kanishka Fatka Factory Pvt Ltd each packet containing 03 pices, MRP each Packets Rs 900/- Toatal = Rs 9900/-
 - 2) 120 Packets Elephant Nera Kothi Fire Crackers made by Indian National Fire Works Elaiyirampannai (via) Shiva each packet containing 10 pices MRP each Packets Rs- 250, Total= 30000/-
 - 3) 110 Packets Chattar Mattar Fatka Fire Crackers made by Karuda Firworks Shivakashi, each packet containing 10 pice packet MRP each Packets Rs 120, Total =13200/-
 - 4) 04 packets Majic Pipe Fire Crackers made by Sri Keliswari Fire Works, Shivakashi, each packet containing 02 pice packet MRP each Packets Rs 365/-, Total =1460/-
 - 5) 04 Packets Dhool Majic Pipe Fire Crackers made by Nayagi Fireworks industries, Shivasakashi each packet containing 02 pice packet MRP each Packets Rs 1148, Total =4592/-
 - 6) 05 Packets Sever Colour Short Maji Pipe Fire Crackers made by Shivakasi each packet containing 05 pice packet MRP each Packets Rs -1035, Total =5175/-
- Total amount worth Rs. 64,327/-.


I ASI Mantu Ghosh of Panitanki Town Out Post, PS- Siliguri, SPC would like to lodge a written complaint against the above noted accused person to the effect that on 19.10.2022 at about 20.15 hrs in course of my evening mobile van duty I received a secret source information that one person is storing huge quantity of Fire cracker for selling at Bidhan Market beside Radha Govinda Mandir, PS- Siliguri, Dist- Darjeeling to the local people illegally. Accordingly I diarised the matter inform to O.C. Panitnaki TOP and as per his kind direction, I along with force Const- 1036 Gopal Srivastav and CV 1007 Jiten Roy rushed to spot i.e. Bidhan Market beside Radha Govinda Mandir, PS- Siliguri, Dist- Darjeeling to verify the veracity of information on arrival at Bidhan market being pointed out by the source found that one temporary shop was opened and selling fire cracker to many persons. Seeing police party the other peoples are fled away except Gouranga Chakraborty (M/52) S/O Lt Subol Chakraborty of Bidya Chakra Colony, ward No. 44, PS Bhakti Nagar, Dist. Jalpaiguri. Accordingly we entered in to the said shop in presence of two disinterest witnesses namely 1) Bapan Das(M/24), S/O Lt Uttam Kr Das of Bhaghajatin Colony, w/n-02, Road No-.02, PO+PS- Pradhan Nagar, Dist Darjeeling and 2) Raju Saha(M/42), S/O Sri Malku Saha Bhaghajatin Colony, w/n-02, Road No-.02, PO+PS- Pradhan Nagar, Dist Darjeeling and on searching found that the said person was storing and selling huge quantity of fire crackers. On being asked he disclosed his identity as noted above and it could be learnt that he has no any reason to open his temporary shop. On being asked the above noted person stated that he was well aware of the verdict of the Hon'ble High Court and he was opening the shop to gain profit. Accordingly, I seized the above noted articles in presence of witnesses duly signed by them. Articles seized in-between 20.55 hrs. to 22.15 hrs. Dated 19.10.2022 as per proper seizure list duly signed by the witnesses and accused person and prepared label. Accordingly, I arrested the above noted accused person U/S 41 Cr.P.C. and intimated the ground of arrest. Hence he has violated the order of the Hon'ble High Court, Kolkata.

Under the above fact and circumstances I pray that a specific Case may kindly be initiated against Gouranga Chakraborty (M/52) S/O Lt Subol Chakraborty of Bidya Chakra Colony, ward No. 44, PS Bhakti Nagar, Dist. Jalpaiguri and arrange for its investigation.
