Sir,

I, Munni Gupta, Wife of Munna Gupta, resident of Prakash Nagar, Sahani Busty, Bhaktinagar P.S., would like to inform you that I have been continuously tortured by my husband namely, Munna Gupta, mother-in-law namely, Sushila Devi Gupta, brother-in-laws namely, Anand Gupta, Chandan Gupta and Sonu Gupta. That I have filed a domestic violence case against them and the same is pending in Court.

That they now and then use abusive language against me and my children and do not provide us with basic amenities with intention to oust us from my shared household. Despite order of the Court I have not been given one kitchen, one bathroom, one toilet facility in the 1st floor and hence I am facing immense hardship moreso, because I am suffering from arthritis, asthma, gallbladder stone, hernia and other diseases. My husband is not providing me any maintenance and I am supported by one NGO.

Today, I came to my neighbour's house from my son's school to show his result. That time my relative Amit Gupta was taking out his motorcycle and as he couldn't balance it properly, it has fallen down. He started to blame my son for the same and I opposed to this and he called me randi, bhikhari. After this, my husband Munna Gupta came near the main gate of my neighbor and he started to assault me and so my son Sourya Gupta came to protect me. Thereafter my husband slapped my son on his face and assaulted him with fists and blows. He even throttled my son's neck saying- "aaj dono ko maar dega" and I tried to rescue my son from his clutches. My husband even assaulted me and pulled me forcefully by my hair and threw me to the ground on rocks and boulders and I got injury and pain and my spectacles went into the drain. That on account of assault my son's school dress was teared off. That even my son got immense injury and pain. That all these assaults were recorded in the cctv footage of my shared household.

Thereafter I and my son were shown in Siliguri Hospital.

I therefore request you to inquire into the matter and take necessary action against my husband Munna Gupta and in-laws.
