I would like to inform you that myself Lakpa Lama, resident of Gandhi Nagar, Sevoke Road, Siliguri, Distt – Jalpaiguri, Pin – 734001, owner of Vehicle Registered No **WB73D/0988** has given my vehicle to Sanik Munda as vehicle Driver, Aadhar No. 787181602514, father Name: Mangal Sing Munda, resident of New Line, Birpara, Dalmore Tea Garden, Birpara – 735204, mobile No. **9382217542**, taken the vehicle rent from AVI logistic delivering the consignment at Jorethang vide Consignment No. 2006 dated 12/10/2022.

On the way towards Jorethang the above said driver has sold some of the goods which was loaded in the vehicle and left the vehicle at the destination point and abscond. But after delivering the goods I came to know that there is a shortage of 68 cases of goods. Now the vehicle driver has already abscond from the destination point with his relative document i.e. driving license and not in my contact after searching everywhere, according to one of my driver's friend named Suman (drivers girlfriend) she has received the call from 8099439360 yesterday night from my driver in her mobile and after till date I am still searching the driver as well as goods.

I would be very thankful if you kindly take the necessary action to trace the driver so that we can found the shortage goods.
