2. 100 (One hundred) packets of SV King Kobra Electric Crackers (Sound crackers) each Packet containing 30 pcs i.e. total (100 x 30)= 3000 pcs weighing total 5.1 kgs.
- 3) 06 (six) packets of STAR'S KRISHNA DELUXE CHOCKLATE ((Sound Bomb) each packet containing 10 pcs i.e. total (6 x 10) = 60 pcs weighing total 950 grams Mfg by Star Enterprise, (India).

I, PSI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned accused person namely Amit Gupta (25 yrs) S/O Anil Gupta of Matigara Bazar, PS- Matigara, Dist.- Darjeeling to the effect that today on 18.10.2021 at 20.20 hrs received a secret information that one Amit Gupta of Matigara Bazar has stored huge quantity of Fire-crackers at his shop at Matigara Bazar for selling the same in the open market for his wrongful gain without having any license or other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 882 dated 18.10.22 and informed the fact to the O/C, Matigara PS. As per your kind order I along with ASI Tapan Das, C/974 Mintu Sen, C/374 Debraj Biswas and others all of Matigara PS, SPC rushed to the spot at Matigara Bazar to work out the information in hand. After arrival at Matigara Bazar, I contacted with my source and being identified by the source, I held raid at the shop of Amit Gupta (25 yrs) S/O Anil Gupta of Matigara Bazar, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On search the above noted illegal fire crackers recovered from his possession. On interrogation he disclosed his identity as noted above and admitted his guilt. Further, on demand he failed to produce any valid documents / license in support of the possession of such quantity of Fire crackers recovered from his shop. There is a reason to believe that accused Amit Gupta (25 yrs) S/O Anil Gupta of Matigara Bazar, PS- Matigara, Dist.- Darjeeling has stored the said consignment of fire crackers for selling the same in the open market for his wrongful gain, which are combustibile in nature and endanger to human life and property at his shop at Matigara Bazar illegally and violating Govt. Orders,. Moreover, the above noted fire crackers were stored without any precautionary and safety measures.
