Respected Sir,

With due respect I, Rakhi Singha Roy, W/O - Ramkrishna Roy, D/O -
Sirat Singha, Resident of Pelkujote, P.O - Ranidanga, P.S -Matigara, Dist - Darjeeling,
beg to inform you that I got married with one namely Ramkrishna Roy, S/O - Hari
Roy, of Kawakhali (near Ration dealer, backside of Dental Collage) in the year 2015
(1st December) and from our aforesaid marriage I have a school going minor son aged
about 5 years who is studying in Alphonsa School.

It is pertinent to mention here that my husband is working in Himalayan
Eye Hospital at Siliguri and an educated person and my father-in-law is an astrologer
having office at his home.

It is very unfortunate that till one month after my marriage everything
was normal in my matrimonial house but just after one month all the family members
of my husband started to torture upon me silently with a plan manner and whenever my
parental family members came to my matrimonial home on every occasion my
matrimonial family members used to insult them by some foul means and my
matrimonial family members always uses filthy languages towards me and my family
members and they never allow me to go to my parental house and they always
threatened me with a dire consequences that if I would go to my parental house in that
event they will not allow me again in my matrimonial house in future.

It is pertinent to mention here that my husband every time uses to assault me and
beat me mercilessly whenever he wishes without any reason and on every occasion my
Father-in-law **Hari Roy** and mother-in-law **Minu Roy** always inspired to my husband
by saying that I should be killed immediately by them rather to restrain from beating
me.

It is to be noted here that one of my Divorcee sister-in-law namely **Aroti Roy**
use to reside in my matrimonial house along with her minor daughter, even my sister-
in-law **Aroti Roy** every time tortured upon me and directed my husband to assault me
on silly matters and with the conspiracy of my parents-in-law, my husband and sister-
in-law used to confined me under Lock and Key in my room with a motive to kill me
on several times.

It is pertinent to mention here that all the family members always directed to me to work all the household works alone and even it was only my duty to prepare the minor daughter of my sister-in-law for school. All the family members of my matrimonial house thinks that I am just a maid servant of their family and they can torture both mentally and physically, assault me at any point of time as they wish.

It is very unfortunate that day before yesterday on 16/10/2022 at about 6.30 pm my husband came home with drunken condition and started to quarrel with me without any reason and on protest my husband mercilessly beaten me and assaulted me heavily and yesterday my husband and my sister-in-law confined me in a room under Lock and Key and at evening they again mercilessly beat me and assaulted me and at night I somehow manage to flee away from my matrimonial house with the help of neighbors and I am not able to take even my Identity Cards or the documents of my son and Subsequently today I visited NBMC & H for my treatment and treated there.

For the sake of my matrimonial life and for the better life of my minor son, I always tried to adjust with them but now it goes to extreme and worst situation for me and my son and it becomes unbearable for me as well as for my son.

Therefore, I am praying before you to enquire into the matter immediately and take a legal action against my husband as well as against all the family members of my husband as soon as possible, please help me.
